Orders of the Day.

Mr. McKINNEY of Bridgton: Mr. Speaker, I desire to make a motion and wish to say a few words in explanation. On last Thursday when the matter of the bench mark on Sebago Lake was taken up I moved to substitute the bill for the report and that it lie on the table for future action. Two members of the committee on interior waters asked that it be taken from the table and re-committed to the committee. That motion was passed by this House by a large vote. It went to the Senate and the Senate have non-concurred in the action of the House. Now I desire to make a motion that the House insist on its action and ask for a committee of conference: and I wish to say, after consultation with the other side that are opposed to this bill, that they have agreed to that action, and I trust that the House

> The order was then given a passage as amended.

> On motion of Mr. Tolman of Portland bill, relating to support and commitment of insane, was taken from the table.

> The bill then received its third reading and was passed to be engrossed.

> On motion of Mr. STEARNS of Norway, bill relating to fishing in Sunday river in Oxford county, was taken from the table.

> Mr. Stearns offered House amendment "A," by striking out all of section three and substituting therefor the following:

> "Section 3. Provided further that this Act shall take effect May 1, 1907, on or before which day the commissioners of inland fisheries and game shall without expense to the state cause notices to be posted in conspicuous places on or near said stream setting forth in substance the provisions of this Act."

The amendment was adopted and
