EXECUTIVE DEPARTMENT.

Augusta, Maine, Jan. 4, 1911.

Speaker of the House of Representatives:

I have the honor to transmit herewith a communication received at this Department from the Secretary of State of the United States, under date fairs, and sent down for concurrence. of July 29, 1909, enclosing a certified copy of a Resolution to Congress, entitled "Joint Resolution proposing an amendment to the Constitution of the United States," the text of which Resolution is as follows, to wit:

'Resolved by the Senate and House rence. of Representatives of the United States of America in Congress (two- it was

thirds of each House concurring therein), that the following Article is proposed as an amendent to the Constitution of the United States, which, when ratified by the Legislatures of threefourths of the several states, shall be valid to all intents and purposes as a part of the Constitution;

'Article XVI. The Congress shall have power to lay and collect taxes on incomes, from whatever sourse derived, without apportionment among the several states, and without regard to any census or enumeration.'"
