SENATE.

Wednesday, January 18, 1911. Senate called to order by the President.

Prayer by R v. Mr. Turner of Hallowell.

Journal of previous session read and approved.

Papers from the House disposed of in concurrence.

Bill, "An Act establishing the Yorkshire Municipal Court," came from the House, by that Branch referred to the committee on Legal Affairs. (On motion by Mr. Gowell of York, this bill was tabled for printing pending reference.)

The following bills, petitions, etc., were presented and referred:

Judiciary.

By Mr. Irving of Aroostook: Bill, "An Act to ratify, confirm, etc., the proceedings of a special town meeting of the inhabitants of Presque Isle, held May 3, 1909 and the bonds issued by said town to aid the Aroostook Valley Railroad Company."

By Mr. Edwards of Androscoggin: Bill, "An Act to authorize the city of Lewiston to take ice for municipal purposes."

Legal Affairs.

By Mr. Winslow of Cumberland: Bill, "An Act to establish a reformatory for women."

By Mr. Fulton of Sagadahoc: Bill, "An Act to enlarge the Village Cemetery of Bowdoinham."

Appropriations and Financial Affairs. By Mr. Foss of Androscoggin: Resolve in favor of Girls' Orphanage in Lewiston, with Statement of Facts.

Agriculture.

By Mr. Moulton of Cumberland: Bill, "An Act to amend chapter 247 of the Public Laws of 1909, relating to grading, packing and branding of apples."

By Mr. Stearns of Oxford: Petition of Benjamin Tucker of Norway and 125 others for change of the laws relating to testing cattle for tuberculosis and horses for glanders.

State Lands and State Roads.

"An Act to regulate the opening of streets in cities."

Reports of Committees.

So much as relates to labor, be referred to the Committee on Labor.

So much as relates to industrial education, be referred to the Committee. on Education.

So much as relates to the General' O. O. Howard Gettysburg monument,. be referred to the Committee on Military.

So much as relates to inland fisheries and game, be referred to the Committee on Inland Fisheries and Game. Respectfully submitted.

On motion by Mr. Moulton of Cumberland, it was

Ordered, the House concurring, that the members of the two Branches of the Legislature convene in joint assembly in the Hall of the House at twelve o'clock Meridian, this on eighteenth day of January, for the purpose of reading the journals of each House relating to the vote for Senator to Congress for the term of six years beginning on the fourth day of March, next, and for such other proceedings in relation to the matter of the election of such Senator to Congress as are required by the Constitution and Statutes of the United States.

The Secretary of the Senate conveyed the order to the House, and reported that he had delivered the order.

Subsequently the order was returned from the House, concurred in by that Branch.

Orders of the Day.

On motion by Mr. Stearns of Oxford, Petition of Amasa Henderson and others of Corinth, in the county of Penobscot, asking that Little Pushaw Pond, in the town of Hudson, county of Penobscot, be closed to all fishing for three years, was taken from the table.

On further motion by the same Senator, the Petition was then referred to the committee on Inland Fisheries and Game, in concurrence.
