#### SENATE.

Wednesday, January 25, 1911. Senate called to order by the President.

Prayer by Rev. Mr. Mosher of Augusta.

Journal of previous session read and approved.

Papers from the House disposed of in concurrence.

Bill, "An Act creating a State board of charities and corrections," came from the House, by that Branch referred to the committee on Judiciary. (On motion by Mr. Winslow of Cumberland, tabled for printing pending reference.)

Petition of H. P. Record and 29 others for change in law regarding testing of cattle and horses for contagious diseases, came from the House, by that Branch referred to the committee on Agriculture. (On motion by Mr. Moulton of Cumberland, tabled pending reference.)
