Monday, Jan. 30, 1911.

Senate called to order by the President.

Prayer by Rev. Coons of Augusta.

Journal of previous session read and approved.

On motion by Mr. Hill of Penobscot, Senate Document No. 30, "An Act to amend Section 3 of Chapter 129 of the Revised Statutes, as amended by Chapter 40 of the Public Laws of 1905, and Chapter 14 of the Public Laws of 1909," was taken from the table.
