#### SENATE.

Thursday, February 2, 1911. Senate called to order by the President.

Prayer by Rev. Mr. Seliger of Augusta.

Journal of previous session read and approved.

Papers from the House disposed of in concurrence.

Bill, "An Act relating to the removal of county attorneys by the Governor," came from the House, by that Branch referred to the committee on Legal Affairs. On motion by Mr. Staples of Knox, the bill was tabled for printing pending reference.

Bill, "An Act to incorporate the Knox County Fewer Transmission Company," came from the House, by that Branch referred to the committee on Judiciary. On motion by Mr. Chandler of Washington, the bill was tabled for printing pending reference to the committee.

Bili, "An Act to amend and unify the laws regulating the sale of agricultural seeds, commercial feeding stuffs, commercial fertilizers, drugs, foods, fungicides and insecticides," came from the House, by that Branch referred to the committee on Agriculture. On motion by Mr. Hill of Penobscot, bill was tabled for printing pending reference.

Bill, "An Act to incorporate the Upper St. John Log Driving Company." came from the House, by that Branch referred to the committee on Interior Waters. On motion by Mr. Theriault of Aroostook, bill was tabled for printing pending reference.

Bill, "An Act to amend Chapter 313 of the Private Laws of the year 1909, entitled 'An Act to abolish Rines Hill grade crossing in Augusta,'" came from the House by that Branch referred to the committee on Railroads and Expresses. On motion by Mr. Noves of Kennehec, bill was tabled for printing pending efference.

The Order in relation to appointing a joint select committee to inquire into the condition of the Portland bridge, and to be known as the Portland Bridge Committee, came from the House, adopted.

The President joined on the committee on the part of the Senate Messrs. Winslow and Foss of Cumberland.

By Mr. Farrington of Kennebec—Bill "An Act amendatory of and additional to Chapter 48 of the Revised Statutes relating to annual examinations of savings banks and trust companies, and verification of savings deposits." (On motion by the same Senator, tabled for printing pending reference to the committee)

#### Agriculture.

By Mr. Boynton of Lincoln—Bill "An Act in relation to the sale of nursery stock under false names, or of an inferior quality."

By Mr. Boynton of Lincoln—Petition of Albert J. Ames and 12 others of Jefferson in favor of the passage of an act to establish a more equitable measure of Jamages in actions at law to recover for the sale of nursery stock under false names or of an inferior quality.

By Mr. Moulton of Cumberland— "Resolve to accept the James J. H. Gregery gift for the promotion of scientific orcharding."

By Mr. Moulton of Cumberland—Bill "An Act to amend Section 2 of Chapter 38 of the Public Laws of 1905."

By Mr. Mayo of Hancock—"Resolve authorizing the State Land Agent to convey Buck and Thrumcap Islands, located in Eggemoggin Reach."

#### Ways and Bridges.

By Mr. Chandler of Washington-"Resolve in favor of town of Addison."

By Mr. Donigan of Somerset-Petition of Ralph Starling and 15 others in tavor of the resolve to aid in a road leading through the town of Moscow and the Plantations of Carratunk and The Forks.

#### Inland Fisheries and Game.

By Mr. Chandler of Washington—Bill, "An Act to prevent putting sawdust and other refuse in the waters of Pleasant River."

By Mr. Blanchard of Franklin—Bill, "An Act to limit the numer of fish which may be taken in one day in certain tributaries to Wilson Lake, which lake is situated in the town of Wilton; also in Alder Brook, a tributary to Wells Pond, which pond is situated in the town

of Wells down as far as Hildreth's mill dam, so called, all in the County of Franklin."

By Mr. Leach of Hancock—Petition of F. C. Atwood and 26 others, residents of Belfast, in the County of Waldo, asking that a law be enacted prohibiting the shipping of wild hares or rabbits outside of the State of Maine.

#### Shore Fisheries.

By Mr. Mayo of Hancock—Petitions of Moody Eaton and 47 others of Deer Isle; Howard P. Lowe and 40 others of Deer Isle; F. E. Hardy and 50 others of Deer Isle; E. G. Stanley and 43 others of Southwest Harbor; E. C. Quin and 7 others of Eagle Island; E. L. Carver and 27 others of North Haven; W. C. Redmond and 24 others of Brooklin for the enactment of law which shall prohibit the catching of herring in the waters of this State, except by use of pernanent weirs or traps.

By Mr. Mayo of Hancock—Petition of P. S. Knowiton and 47 others of Deer Isle for a close time on scallops in East Penobscot Bay. (On motion by the same Senator, placed in file, as the subject matter had been acted upon.)

By Mr. Chandler of Washington—Petition of Harry Brown and 39 others of Addison against any change in the law in relation to the taking of smelts in Pleasant River.

By Mr. Allan of Washington—Petition of B. E. Lurchin and 16 others of Pembroke for the enactment of a law for the better protection of spawn smelts in Pembroke River.

Mr. Milliken for the committee on Interior Waters on "An Act to further enable the Sebago Lake, Songo River and Bay of Naples Steamboat Company to construct and maintain wharves along its routes," reported same "ought to pass."

Mr. Donigan for the committee on Interior Waters, on "An Act to incorporate Dam Company," reported the Moxie same "ought to pass."

The reports were accepted, and the bills ordered printed und r the joint rules.
