#### SENATE.

Thursday, February 9, 1911.

Senate call d to order by the President. Prayer by Rev. Mr. Dana of Hallowell. Journal of previous session read and approved.

Papers from the House disposed of in concurrence.

Resolve in favor of the town of Peru, came from the House, by that Branch referred to the committee on Claims. Tabled on motion by Senator Milliken of Arcostook.

The following bills, petitions, etc., were presented and referred:

#### Legal Affairs.

By Mr. Farrington of Kennebec—Bill, An Act to amend Section 10, Chapter 3, Revised Statutes, relating to the powers and duties of the Maine Library Commission.

By Mr. Winslow of Cumborland-Bill, An Act to incorporate the World's Standard Insurance company.

Appropriations and inancial Affairs, By Mr. Allan of Washington-Resolve in favor of Frank W. Buckman, Secretary of Commission of Pharmacy.

'ariculture,

By Mr. Moulton of Cumberland-Bill, An Act to render more wholesome the mi'k supply of cities and towns.

Also, Bill, An Act to amond Section 6 of Chapter 242 of the Public Laws of 1909.

Also, Bill, An Act to provide for the appointment of a State Sealer of weights and measures and to define his duties.

Also, Resolve in favor of the College of Agriculture of the University of Maine.

By Mr. Hill of Penobscot—Bill, An Act for the extirpation of contagious diseases among cattle, horses, sheep and swine. (Tabled for printing on motion of the same Senator.)

#### Temperance,

By Mr. Milliken of Aroostook-Bill, An Act to amend Section 1 of Chapter 136 of the Revised Statutes relating to sentence in criminal cases. On motion by the same Senator, the bill was tabled for printing, pending reference.)

By Mr. Irving of Arcostook—Remonstrance of A. L. Smith, M. D. and 54 others of Machias against resubmission; also remonstrance of Rev. A. W. Blackford and 60 others of Machias against same. (On motion of Mr. Boynton of Lincoln, placed on file.)

#### Reports of Committees.

Mr. Farrington, for the committee on Banks and Banking, on An Act to extend the charter of the Sagadahoc Trust company, reported that the same "ought to pass."

Mr. Kellogg, for the committee on Interior Waters, on An Act to incorporate the Sawtelle Brook Dam and Improvement Company, reported a new draft under the same title and that it "ought to pass."

The reports were accepted and the bills tabled for printing under the joint rules.

Mr. Noves, for the committee on Taxation, on Resolve in favor of the owners of Townshin 8, Range 9, N B P P, reported that the same be referred to the committee on Claims.

The report was accepted and sent down for concurrence.

#### Orders.

On motion by Mr. Chandler of Wash-ington, it was-

Ordered, that the secretary of the Senate prepare and cause to be printed under his supervision and direction three hundred copies of the journal of the proceedings of the present session of the Senate.

An Act to extend the charter of the Sebec Power Company. (On motion by Mr. Milliken of Aroostook, tabled pending its passage to be engressed.

An Act to permit the Plantation of Fighland to assume the maintenance of its roads and bridges.

An Act to provide for a close time on scallops.

An Act to authorize the construction

and maintenance of a bridge over flats and tide-waters in Back river in the town of Boothbay.

An Act to authorize the Mousam Water Company to increase its capital stock and extend to Fortunes Rocks.

An Act to authorize the erection of a dam across the East Branch of Spruce Creek in the town of Kittery.

An Act to authorize the Lewiston Gas Light Company to increase its capital stock and issue bonds.

Private and Special Laws of 1903, as amended, relating to fishing in Gull pond, in Dallas Plantation, in the county of Franklin.

An Act to amend Chapter 291 of the Private and Special Laws of 1909, relating to fishing in Indian River stream in Washington county.

An Act to regulate fishing in Little Lobster lake, so called, in the county of Piscataquis.

An Act to extend the charter of the Sagamore Insurance Company. (On motion by Mr. Milliken of Aroostook, pending second reading, the following amendment was adopted: Amend by striking out Section 1, "This Act shall take effect when approved.") On further motion by the same Senator, the bill was read a second time and passed to be engrossed.
