SENATE.

Monday, February 20, 1911. Senate called to order by the President.

Prayer by Rev. Fr. LaReviere.

Journal of previous session read and approved.

Papers from the House disposed of in concurrence.

All those requests for increases of salary by county officials were denied. Τ have no objection to this particular bill, but wish to call attention to what is happening here. We are having many of these requests sent to the county delegations and passed there, and we shall find ourselves at the end of the session as having decreed numerous increases in salaries of county officials.

> Mr. NOYES of Kennebec: Mr. President: I will say in regard to the bill that in the hearing before the Kennebec county delegation, no one appeared against it. It is simply an increase in clerical hire.

> Mr. MILLIKEN: Mr. President: Т am not interested particularly in this matter. But I want to say on that point that no one was ever known to appear against an application for an increase in salary, and also that an increase in clerk hire is about the same as an increase of salary.

> Mr. KELLOGG of Penobscot: Mr. President: I move that the bill lie on the table pending second reading. The motion was agreed to.

Papers from the Senate disposed of in concurrence.

Bill ratifying and confirming the sale of the railroad and franchises of the Atlantic Shore Line Railway and the incorporation of the Atlantic Shore Railway, came from the Senate amended by Senate Amendment A.
