Now I am aware of the fact that there is considerable unfinished business in the hands of the committee on education. I would like to inquire through the Chair of the Chairman of that committee what prospect there is of that business being cleaned up by March 20th, and whether or not it is to be left with unfinished business, or whether the committee will ask for additional time.

This resolve originally asked for \$560. It was finally cut down to \$96 and I think it is \$96 yet. The fact is that Capt. McDonald is a steamboat inspector, and in 1907 he bought a team specially to transport him from his home to the station, and he charged the regular fee. Our auditor, Mr. Hatch, refused to allow the bill because it was his own team. That fall he sold the team and since then he has been transported back and forth by a hired team and the State has never refused to pay the bill.

I did not know but the matter might be hauled up in the House, but I really thought it might go through the Senate.

accord with the position taken in the House and Senate for the past few days.

Of what use has it been for us to be here this winter at an expense to the State, to advertise these hearings in the papers, to sit here hour after hour in these committees and pass upon and report "ought to pass" or "ought not to pass" on these different measures?

In all of these committees, or in the principal part of them, these appropriations have been cut down to the very lowest notch; as you might say, right down to bare poles. They have been reported in the House and Senate, and have been held up in the House. For what purpose? For the purpose which has been carried out here in the last few days! I say it is unjust. Here are from 150 to 200 different bills and resolves carrying small appropriations into every part of this State. They affect a lot of people; they have been turned down, or referred to the next Legislature. As our friend has said, it looks like boys' play to me.

This morning there have been passed through here 25 or 30 resolves and bills carrying appropriations to different institutions all over the State, large and small. If there were need of cutting down the resolves and bills referred to the next Legislature, why not put the knife into these that passed here this morning?

I want to say that I do not stand here this morning under the whip of the Democratic party. I, with the senator from Knox, realize that we cannot do anything to prevent it, but I want to go on record that I am opposed to it. I want to say right here that in two years from this time, the Democratic party will reap the benefit of this action.
