SENATE.

Friday, March 31, 1911.

Senate called to order by the President.

Prayer by Rev. Mr. Allen of Jonesboro.

The PRESIDENT: I find there are two matters on the table that were omitted last evening. One is the report of the committee on education relative to the Farmington Normal School, tabled by Mr. Milliken of Aroostook.

On motion by Mr. Milliken, Resolve in favor of Farmington State Normal School was taken from the table.

Mr. MILLIKEN: Mr. President, that matter came in the other day, and through a misunderstanding of the endorsement when brought over from the House, the resolve was acted on here. As a matter of fact, it was referred to the next Legislature in the House, and I now move that the Senate concur in the action of the House in referring this resolve to the next Legislature.

The motion was agreed to, and the resolve was so referred.

On motion by Mr. Gowell of York, An Act relating to abandoned burying grounds was taken from the table.

Mr. GOWELL: Mr. President, the people interested in this measure are away and I do not wish at this late day of the session to ask for a committee of conference, and I now move that we concur in the action of the House in indefinitely postponing this bill.

The motion was agreed to and the bill was indefinitely postponed.
