SENATE.

Wednesday, Jan. 1, 1913.

Pursuant to the provisions of the constitution and laws of the State of Maine, the senators-elect to the 76th Legislature convened in the Senate Chamber and were called to order by William C. Hanson, secretary of the Senate of 1911.

Prayer was offered by Rev. C. G. Mosher of Augusta.

The following communication was read by the secretary:

STATE OF MAINE.

The roll being called, the followingnamed senators-elect responded their names; Messrs. Herbert H. Allan, Joseph W. Allen, Taber D. Bailey, Leslie Boynton, Albert Α. Burleigh, Charles J. Chase, Cecil F. Clark, Forrest H. Colby, Aaron B. Cole, Charles M. Conant, Frank L. Dutton, George G. Emery, Edward F. Flaherty, Alexander C. Hagerthy, David R. Hastings, Ira G. Hersey, Ephraim B. Jillson, George F. Mansfield, Noble Maxwell, Carl E. Milliken, Frank A. Morey, H. M. Moulton, Edward W. Murphy, Arthur B. Packard, J. Herbert Patten, Willington T. Reynolds, George H. Richardson, Charles E. Smith, Albert J. Stearns, William L. Walker, Herbert S. Wang-31, and 31 senators-elect Seventh Senatorial District-Frank having answered to their names, a quroum was declared present.

Mr. Stearns of Oxford moved that a message be sent to the Governor and Council informing that body that a quorum of senators-elect of the 76th Legislature is present in the Senate Chamber, ready to take and subscribe the oaths of office to qualify them to enter upon their official duties. The motion being duly seconded, prevailed, and Senator Stearns of Oxford was appointed to convey such message and thereafter reported that he had de-Eleventh Senatorial District-Leslie livered the messag with which he was charged.

Senators Take the Oath.

The Governor and Council thereupon came in, before whom the senatorselect took and subscribed the oaths required by the Constitution, and the Governor and suite then withdrew.

On motion by Mr. Colby of Somerset, that senator with Messrs. Richardson of Penobscot and Allan of Washington were appointed by the secretary a committee to receive. and count votes for sort President of the Senate. The committee reported 29 votes cast and Carl E. Milliken of Aroostook received 20, and Leslie Boynton of Lincoln received 9.

The report was accepted and Carl E. Milliken of Aroostook was declared elected President of the Senate for the political years 1913 and 1914.

Mr .Boynton of Lincoln was appointed to conduct the President to the chair.

Mr. BOYNTON of Lincoln: Senators: It is indeed a particular privilege for me to be able to present to you your newly elected President of the Senate, Senator Milliken of Aroostook.

The PRESIDENT: Brother Senators: It is a special privilege to me to accept this gracious courtesy at the hands of my dear friend, the senator from Lincoln. And no words at my command can express to you my deep appreciation of the honor you have conferred upon me. I shall need, constantly, and I shall confidently expect, your tolerance—for my mistakes will be many—your co-operation, in the work we shall try to do together, and a continuance of the same kindly spirit you have shown towards me.

I pledge you, upon my part, that my constant effort will be to preside over your deliberations with absolute fairness and impartiality, and I assure you that at all times I am at your service in the interest of our common duties here.

We are here, Senators, if you please, as directors in a great corporation. We are to transact the business of the people of the State of Maine. There occasionally will be differences of opinion as to where the interests of the people may lie, but there is no

difference in the mind of any senator present as to the motive that will inspire us all. And no personal interest, no sectional interest, even, will intervene, I know, between the mind of any senator and what he considers to be the welfare of the whole people of our great State. Again, I thank you and the Chair awaits the pleasure of the Senate. (Applause.)

On motion of Mr. Bailey of Penobscot, that senator with Messrs. Cole of York and Flaherty of Cumberland, wereappointed a committee to receive, sert and count votes for secretary of the Senate. The committee reported 30 votes cast. William E. Lawry had 20. W. C. Hanson, 10.

The report was accepted and William E. Lawry was declared elected secretary of the Senate. Senator Bailey of Penobscot was appointed by the Chair to cenduct the secretary-elect to the Council chamber to take and subscribe the necessary oaths of office before the Governor and Council. Subsequently that senator announced that Mr. Lawry had taken and subscribed said oaths of office, and the secretary of the Senate thereupon entered upon the discharge of his official duties.

On motion by Mr. Wing of Franklin, that senator with Messrs. Patten of Hancock and Packard of Knox were appointed a committee to receive, sort and count votes for assistant secretary of the Senate. The committee reported 28 votes cast. L. Ernest Thornton had 19, H. L. Thurlough 9.

The report was accepted and L. Ernest Thornton was declared assistant secretary of the Senate. The assistant secretary of the Senate thereafterwards took his oath of office.

On motion by Mr. Chase of Piscataquis, that senator with Messrs. Clark of York and Morey of Androscoggin were appointed a committee to receive, sort and count votes for messenger. The committee reported 31 votes cast. Charles H. Lovejoy had 31.

The PRESIDENT: It is with peculiar pleasure that the Chair announces the unanimous choice of Charles H. Love-joy of Sidney as messenger of the Senate.

On motion of Mr. Burleigh of Aroos-

took, that senator, with Messrs. Max- Senate be authorized to appoint two well of Sagadahoc and Hastings of pages for the Senate. Androscoggin were appointed a committee to receive, sort and count vetes for assistant messenger. The committee reported 28 votes cast. J. Ashford had 23, J. B. Potter 5.

The report was accepted and J. F. Ashford was declared duly elected assistant messenger.

On motion by Mr. Conant of Waldo, that senator and Mr. Hagerthy of Hancock and Mr. Jillson of Cumberland were appointed a committee to receive, sort and count votes for folder. The committee reported 29 votes east. John W. Higgins had 19, W. R. Fairclough had 10.

The report was accepted and John W. Higgins was declared duly elected folder.

On motion by Mr. Emery of York, that senator with Messrs. Moulton of Cumberland and Smith of Penobscot were appointed a committee to receive, sort and count votes for assistant folder. The committee reported 29 votes cast. Claude W. Townsend, Jr., had 19. Charles Lamere 10.

The report was accepted and Claude W. Townsend, Jr., was declared duly elected assistant folder.

On motion by Mr. Hersey of Aroostook, that senator with Mr. Stearns of Oxford and Murphy of Cumberland were appointed a committee to receive, sort and count votes for doorkeeper. The committee reported 29 votes cast. Stephen B. Lord had 22, Alonzo G. Dennis 7.

The report of the committee was accepted and Stephen B. Lord was declared duly elected doorkeeper.

On motion by Mr. Walker of Somersent, that senator with Messrs. Reynolds of Kennebec and Boynton of Lincoln were appointed a committee to receive, sort and count votes for postmaster. The committee reported 30 votes cast. Arthur A. Knight had 20, Ralph Trim had 10.

The report of the committee was accepted and Arthur A. Knight was declared duly elected postmaster.

On motion of Mr. Colby of Somerset it was

The President then announced the appointment of John F. Lock of Mt. Vernon and Percie F. Cram of Whiting.

On motion of Mr. Clark of York, it was

Ordered: That the Secretary of the Senate be authorized to secure the services of a stenographer and typewriter operator during the present session of the Legislature.

On motion of Mr. Conant of Waldo, it was

Ordered: That Fred W. Lee of Augusta be appointed official reporter of the Senate with the compensation fixed at the same amount as that of the official reporter at the last regular session.

On motion of Mr. Bailey of Penobscot, it was

Ordered: That a committee of seven be appointed by the President, to whom the returns of the votes for senators for the political years of 1913-14 shall be forwarded for and report.

The President thereupon appointed as such committee Messrs. Bailey of Penobscot, Chase \mathbf{of} Piscataquis, Walker of Somerset, Conant of Waldo, Clark of York, Hastings of Androscog gin, Boynton of Lincoln.

On motion of Mr. Stearns of Oxford, it was

Ordered: That returns of votes for Governor given in the several cities, towns and plantations of the State for the political years of 1913 and 1914 be referred to a joint select committee of seven on the part of the Senate with such as the House may join.

The President appointed as the committee on the part of the Senate, to whom the votes for Governor shall be referred, Messrs. Stearns of Oxford, Burleigh of Aroostock, Reynolds Kennebec, Maxwell of Sagadahoc, Morey of Androscoggin, Packard of Knox, Allan of Washington.

On motion by Mr. Hersey of Aroostook, it was

Ordered: That a message be sent to the House of Representatives in Ordered: That the President of the forming that body that the Senate is duly organized by the choice of Hon. Carl E. Milliken of Aroostook as President; William E. Lawry as secretary, and L. Ernest Thornton as assistant secretary, and that Senator was appointed to convey said message. Subsequently that Senator reported that he had delivered the message with which he was charged.

On motion of Mr. Emery of York, it was

Ordered: That a message be sent to the Governor and Council in forming that body that the Senate is duly organized by the choice of Hon. Carl E. Milliken of Aroostook as President; William E. Lawry as secretary, and E. Ernest Thornton as assistant secretary, and that Senator was appointed to convey said message and subsequently reported that he had delivered the message with which he was charged, and that the Governor wished him to say that he congratulates this Senate upon its wise choice selecting such efficient officers.

On motion of Mr. Wing of Franklin it was

Ordered: That the rules and orders of 1911 be the rules and orders of the Senate until otherwise ordered.

On motion by Mr. Allen of Kennebec it was

Ordered, That the secretary of the Senate be directed to furnish each member and officer of the Senate one copy of the Kennebec Journal and two other daily papers published in the State, such as each member and officer may select.

On motion by Mr. Smith of Penobscot, it was

Ordered, That the secretary of the Senate prepare and have printed 150 diagrams of the Senate Chamber for the use of the Sena's.

On motion by Mr. Dutton of Kennebec, it was

Ordered, That the secretary of the Senate prepare the usual register of the Senate and that 800 copies of the same be printed for the use of the Senate.

On motion by Mr. Mansfield of Washington it was

Ordered, That the secretary of the Senate be directed to invite the clergy-

men of Augusta, Hallowell and Gardiner to officiate as chaplains of the Senate in rotation, during the present session.

On motion by Mr. Cole of York it was

Ordered, That the secretary of the Senate be directed to furnish for the use of the Senate four copies of the Revised Statutes of the State, one copy each of the Holy Bible, Webster's International, Worcester's Unabridged and Standard Dictionaries, Lippencott's Pronouncing Gazeteer, Reed's Rules and Cushing's Law and Practice of Legislative Assemblies.

On motion by Mr. Colby of Somerset it was

Ordered, That the secretary of the Senate provide each member and officer of the Senate with a copy of the Acts and Resolves of 1911.

On motion by Mr. Patten of Hancock it was

Ordered, That the Senate hold one session a day commencing at 10 o'clock in the forenoon until otherwise ordered.

On motion by Mr. Emery of York it was

Ordered, The House concurring, that the joint rules and orders of 1911-12 be adopted as the joint rules and orders of this Legislature, with the following amendments: In rule strike out the words "State Roads" and substitute in place thereof the words "Forest Preservation;" and add after the words "On School for Feeble Minded." $_{
m the}$ words "On Public Health.'

On motion by Mr. Allen of Kennebec it was

Ordered, the House concurring, that the superintendent of public buildings is hereby given charge of all assignments for hearings in the Capitol building, and that all applications for rooms for hearings must be made to him in writing, 48 hours previous to being used for that purpose.

Sent down for concurrence. Subsequently this order came back from the House, that branch having concurred in the action of the Senate.

STATE OF MAINE.

Office of Secretary of State, Augusta, Jan. 1, 1913.

To the Senate and House of Representatives:

By order of the Governor and Council, I have the honor to herewith transmit a report of the votes cast at the election, Sept. 11, 1911, upon the amendments to the Constitution of the State proposed by Chapters 210 and 221 of the resolves passed at the regular session of the Legislature of 1911, and of the votes case at the election, Sept. 9, 1912, upon the amendment tothe Constitution of the State proposed by Chapter 1 of the resolves passed by said Legislature in special session, in 1912.

Upon the amendment proposed by Chapter 210 of the resolves of 1911, providing that Augusta is declared to be the seat of government of this State, there were 59,678 votes in the affirmative and 41,294 votes in the negative.

Upon the amendment proposed by Chapter 221 of the resolves of 1911, providing that towns having a population of 40,000 inhabitants or more, according to the last census taken by the United States, be permitted to create a debt or liability which, single or in the aggregate, equals seven and one-half per centum of its last regular valuation and that the increase in amount of debt be no greater than one-quarter of one per centum over the present rate of 5 per cent. in any one year, there were 39,242 votes in the affirmative and 38,712 votes in the negative.

Upon the amendment proposed by Chapter 1 of the resolves passed by the Legislature in special session, in 1912, providing for the issuing of State bonds for the purposes of building and maintaining State highways, there were \$0.619 votes in the affirmative and 21,454 votes in the negative.

A message was received from the House of Representatives, conveyed by Mr. Scates of Westbrook, that the House was duly organized for the 76th Legislature. by the election of John A.
