SENATE.

Monday, February 3, 1913. Senate called to order by the President.

Prayer by Rev. Leroy W. Coons.

Journal of previous session read and approved.

Papers from the House disposed of in concurrence.

An Act to amend Section 69 of Chapter 66 of the Revised Statutes relating to authority of foreign executors, administrators, guardians and trustees.

An Act to amend Sections 13 and 14 of Chapter 73 of the Revised Statutes, relating to sales of estates of non-resident owners.

An Act to amend Chapter 504 of the Private and Special Laws of 1889, incorporating the Otter Creek Bridge Company.

These bills came from the House by that Branch referred to the committee on judiciary. On motion by Mr. Hersey of Aroostook, they were tabled for printing pending reference.

An Act to amend Section 28 of Chapter 65 of the Revised Statutes, relating to appeals from orders, sentences, decrees or denials of judges of probate, came from the House by that Branch referred to the committee on legal affairs, and on motion by Mr. Bailey of Penobscot, was tabled for printing pending reference in concurrence.

An Act to amend Section 50 of Chapter 93 of the Revised Statutes, relating to liens on pulp wood, came from the House, by that Branch referred to the committee on legal affairs, and on motion by Mr. Bailey of Penobscot, was tabled for printing pending reference in concurrence.

An Act to incorporate the Corinna Water Company, came from the House, by that Branch referred to the committee on legal affairs, and on motion by Mr. Hastings of Androscoggin, was tabled for printing pending reference in concurrence.

An Act to amend Section 54 of Chapter 8 of the Revised Statutes, re-

lating to taxation of savings banks, came from the House, by that Branch referred to the committee on banks and banking, and on motion by Mr. Allen of Kennebec was tabled for printing pending reference in concurrence.

An Act to amend Section 25 of Chapter 48 of the Revised Statutes, relating to investment of deposits in savings banks and institutions of savings, came from the House, by that Branch referred to the committee on banks and banking, and on motion by Mr. Allen of Kennebec, was tabled for printing pending reference in concurrece.

Resolve in favor of the Stock Breeding Association, came from the House, by that Branch referred to the committee on agriculture, and on motion by Mr. Cole of York, was tabled for printing pending reference.

Peition of Harry Quimby of Rangeley and 36 others, residents of Rangeley and vicinity, asking that a law be enacted prohibiting all the fishing in Rangeley Lake, Cupsuptic and Mooselucmeguntic Lakes except by trolling or by artificial flies cast in the usual manner, came from the House by that Branch referred to the committee on inland fisheries and game, and on motion by Mr. Stearns of Oxford, was tabled.

An Act relating to the taxation of telegraph companies, came from the House by that Branch referred to the committee on taxation, and on motion by Mr. Allen of Kennebec, was tabled for correction of title pending reference in concurrence.

An Act to change the shire town of Alfred in York county to the city of Saco, came from the House, by that Branch referred to the York county delegation, and on motion by Mr. Cole of York, was tabled for printing pending reference in concurrence.

An Act to amend Chapter 118 of the Laws of 1905, relative to the clerk hire of the clerk of courts in York county, came from the House, by that Branch referred to the York county delegation, and on motion by Mr. Stearns of Oxford, was tabled for

Mr. RICHARDSON of Penobscot: Mr. President, I move we non-concur with the action of the House on this petition, and I make the motion by request of the committee who say there is new information bearing on the subject and they wish the bill recommitted to them.

Passed to be Engrossed.

An Act relating to; the Home for Aged Women in Portland.

An Act to amend Section 1 of Chapter 125 of the Public Laws of 1909, relating to the State superintendent of public schools.

Mr. DUTTON of Kennebec: Mr. President, I move that this bill, relating to the State superintendent of public schools, lie on the table pending second reading.

Mr. WALKER of Somerset: Mr. President, I would ask through the Chair that the senator assign some date for the consideration of this matter.

Mr. DUTTON: Mr. President, I hope the senator from Somerset will not ask me at this time to assign a time. I am slightly at disadvantage with the senator from Somerset as to the arguments in favor of this bill, and before I assign it, would like to inform myself of some of the reasons why it should become a law, and I ask the Senate to allow the bill to lie on the table at this time, as there does not seem to be any hurry about the matter.

Mr. WALKER: Mr. President, I have personal knowledge that there are several positions in other states at a much larger salary which are open to our very efficient State superintendent of public schools, and in justice to him as well as those parties who desires to obtain for themselves his services, I would ask the senator not to have this matter lie upon the table for any length of time.

The PRESIDENT: The Chair desires to call the attention of the Senate to the fact that this motion to lay on the table is not debatable, except on the question of date of assignment.

Mr. DUTTON: Mr. President, I will assure the senator from Somerset that I will not cause any extended delay.

(The bill was tabled pending second reading.)

On further motion by the same senator, the bill was referred to the committee on judiciary and sent down for concurrence.

On motion by Mr. Stearns of Oxford, the vote whereby bill, An Act relative to compensation to employes for personal injuries received in the course of their employment and to the prevention of such injuries, was tabled for printing, was reconsidered.

On further motion by the same senator, the bill was tabled for printing and 1000 extra copies ordered printed for the use of the Legislature.

On motion by Mr. Packard of Knox, unanimous consent was given and that senator introduced out of order, An Act to amend Chapter 2 of the Public Laws of 1911, relative to scallops.

On further motion by the same senator, the bill was referred to the committee on sea and shore fisheries and sent down for concurrence.

On motion by Mr. Hersey of Aroostook, Senate Document 143, An Act to prevent the evasion of payment of telephone charges, was taken from the table, and on further motion by the same senator, was referred to the committee on judiciary in concurrence.

On motion by the same senator, Senate Document 145, Resolve for an amendment of the Constitution providing for the proposal of amendment by initiative petition, was taken from the table, and on further motion by the same senator, was referred to the committee on legal affairs in concurrence

On motion by the same senator. Senate Document 151, An Act to create the Smyrna Water Company was taken from the table, and on further motion by the same senator, was referred to the committee on judiciary in concurrence.

On motion by the same senator, Senate Document 151, An Act to create the Oakfield Water Company, was taken from the table, and on further motion by the same senator, was referred to the committee on judiciary in concurrence.

On motion by Mr. Bailey of Penobscot, Senate Document 139, An Act to regulate the practice of professional public accounting, was taken from the table, and on further motion by the same senator, was referred to the committee on judiciary in concurrence.

On motion by the same senator, Senate Document 144, an Act to authorize Calais Street Railway to sell electricity, was taken from the table, and on further motion by the same senator, was referred to the committee on legal affairs in concurrence.

On motion by the same senator, an Act amending Section 7 of Chapter 15 of the Public Laws of 1907, defining the limits within which municipalities shall destroy dangerous in-

sects, was taken from the table, and senator, was referred to the committee on further motion by the same senator, was referred to the committee on agriculture in concurrence.

On motion by Mr. Colby of Somerset, Senate Document 140, an Act to incorporate the Madison Water District, was taken from the table, and on further motion by the same senator, was referred to committee on judiciary in concurrence.

On motion by the same senator, petition for an act to incorporate the Madison Water District, was taken from the table, and on further motion by the same senator, was referred to the committee on judiciary in concurrence.

On motion by Mr. Cole of York, Senate Document 148, an Act to improve the cattle industry and increase the number of cattle in the State, was taken from the table, and on further motion by the same senator, was referred to the committee on agriculture.

On motion by Mr. Boynton of Lincoln. Senate Document 142, an Act to amend Chapter 55 of the Private and Special Laws of 1903, as amended by Chapter 12 of the Private and Special Laws of 1909, relating to Squirrel Island Village Corporation, was taken from the table, and on further motion by the same senator, was referred to the committee on judiciary in concurrence.

On motion by the same senator, Senate Document 147, an Act granting to Hollis M. Shaw pole rights in the streets and highways of the towns of Union and Warren in the county of Knox, was taken from the table, and on further motion by the same senator, was referred to the committee on judiciary.

On motion by Mr. Hersey of Aroostook, an Act to set off Capitol Island and Squirrel Island from the town of Southport, was taken from the table. and on further motion by the same

On motion by Mr. Jillson of Cumberland, Senate Document 137, an Act to provide adequate punishment for any person who shall engage or act in the capacity of a locomotive engineer or a train conductor upon any railroad in the State of Maine, as hereafter provided in this Act. To punish any person who shall knowingly engage, promote, require, persuade, prevail upon or cause any person to do any act in violation of this Act. was taken from the table, and on further motion by the senator, was referred to the committee on railroads and expresses.

On motion by Mr. Cole of York. Senate Document 149, an Act to authorize and empower the county commissioners of the county of York to raise and expend a certain sum of money on the court house and county offices connected therewith, was taken from the table, and on further motion by the same senator, was referred to the York county delegation.

Mr. MOREY of Androscoggin: Mr. President, I am informed that Senator Wing, who is not present, is willing that an Act establishing a uniform poll tax, be taken from the table. I therefore move that Senate Document 150, be taken from the table.

The motion was agreed to, and on further motion by the same senator. the bill was referred to the committee on taxation.

On motion by Mr. Jillson of Cumberland, Senate Document 138, Resolve in favor of the Bath Military and Naval Orphan Asylum, was taken from the table, and on further motion by the same senator, was referred to the committee on appropriations and financial affairs in concurrence.

On motion by M. Maxwell of Sagadahoc, adjourned until tomorrow morning at 10 o'clock.
