The PRESIDENT: The Chair desires to announce, in reference to the time limit on private and special legislation, that apparently there has some misuncer-standing arisen in the House as to wheth-er the time limit, being February 5th, means that resolves, petitions or bills, involving special legislation, must be act-ually presented in the Senate or House today, or that such papers may be put in the box this afternoon for presentation tomorrow morning. The Chair is in-formed that the impression has prevailed in the House that petitions, resolves or bills, placed in the hands of the secretary of the Senate or the clerk of the House this afternoon before 4 o'clock will be within the time limit. For the sake of uniformity and to prevent any embarrass-The PRESIDENT: The Chair desires to uniformity and to prevent any embarrassment on the part of the members of the House who have had this understanding, the Chair wishes to rule in harmony with the rule of the House, that private and special legislation placed in the hands of the secretary of the Senate by 4 o'clock this afternoon may be considered within the time limit provided by the rules.
