#### Crders of the Day.

The PRESIDENT: The Chair lays before the Senate for consideration and especially assigned for this morning, an Act to amend Section 1 of Chapter 125 of the Public Laws of 1909 relating to the State superintendent of public schools.

Mr. DUTTON СĔ Kennebec: Mr. President, I yield the floor at this time to the senator from Somerset, Senator Walker.

Mr. WALKER of Somerset: Mr. President, I move that this matter lie on the table and be especially assigned for consideration, tomorrow morning.

The motion was agreed to.

On motion by Mr. Hersey of Aroostook, Senate Document 176, An Act to incorporate the Houlton Street Railway Company was taken from the table, and on further motion by the same senator, was referred to the committee on railroads and expresses.

On motion by the same senator, An Act to amend Section 61 of Chapter 7 of the Revised Statutes, tabled for correction of title, was taken from the table, and on further motion by the same senator, was tabled for printing pending reference.

On motion by the same senator, An Act to amend Section 62 of Chapter 7 of the Revised Statutes, tabled for correction of title, was taken from the table, and on further motion by the Resolve in favor of Fort William same senator, was tabled for printing pending reference.

Mr. STEARNS of Oxford: Mr. President, when this matter was tabled, it was because of the fact that it cecurred to me it should be referred to the committee on salaries and fees, more about the matter than the commit-Since that time, I understand York County Delegation-as this is a very small matter, the delegation

is willing to have it referred to them, and the committee on salaries and fees has no desire that it should be referred to them. It being satisfactory to both the committee and to the York County Delegation, I have no objecttion to its being so referred. I movo that the bill be referred to the York County Delegation.

Mr. HERSEY of Aroostook: Mr. President, there is one matter pending before this Senate in which we have non-concurred with the action of the House, or they with us, in the reference of the matter to the committee on salaries and fees, it having referred the matter to the county delegation. It seems to me, Mr. President, that if we are referring all matters of salaries and fecs, and clerk hire and all those things, at this time, to county delegations, and the county delegation is to report directly to the House and Senate and not to the committee on salaries and fees, if the delegations are to report to the committee on salaries and fees, I have no objection, but if they report, as I understand they would, to the House or Senate from which the bill comes, I do have serious objection. I think each delegation should be dealt with the same; that no have any county delegation should preference; no delegation should consider clerk bire and report to the Legislature. It should report to the committee on salaries and fees.

I hope the senator will withdraw his motion.

Mr. COLE of York: Mr. President, this is a matter which particularly affects the York County Delegation. It is perhaps one of the unfortunate things in a county in which no one will be hurt and some benefited. I think it will be better to have it go to the county delegation. It is not a matter for increase of salary; it is simply a readjustment of things as they were a few years ago. I believe it would be better to leave it in this case to the York County Delegation where an understanding may be had by the people directly interested in it and who know the tee on salaries and fees. The committee would be obliged to have a hearing here, and the parties interested would on the delegation knows about this mat- motion by the same senator, was referred ter, and it could go along and be adjust- to the committee on judiciary in concured. It seems to me it should go to the delegation, but if the senator wishes us to report to the committee on salaries and fees, it can be done. In this case 1 hope it will go to the York County Delegation.

Mr. DUTTON of Kennebec: Mr. President. I desire to say that I have no objection to this matter going to the York County Delegation. I understand this is a matter of about \$100 involved for clerk hire. Very early in the session I introduced into this body a very similar bill in reference to clerk hire in the probate court of Kennebec county, involving the sum of \$200, and at the request of senators I tabled that matter and waited for the time when the committee on salaries and fees should be appointed. Nobody would be hurt. It is a just demand in our case, and no doubt it is in the case of York county, but I think all should be used alike. I have no doubt that this bill for clerk hire is paid out of the county treasury, the same as ours is in Kennebec county. And it might be that the whole State at large has no special interest in it, if the county is willing to pay that amount: but it seems to me that all should be used alike even in these trivial matters.
