SENATE.

Wednesday, February 12, 1913. Senate called to order by the President.

Prayer by Rev. Father LaRiviere of Augusta.

Journal of previous session read and approved.

Papers from the House disposed of in concurrence.

House Document 186, An Act to encourage and promote the building and use of tuberculosis hospitals in cities and towns, came from the House by that Branch referred to the committee on judiciary, and on motion by Mr. Stearns of Oxford, was tabled pending reference in concurrence.

An Act relating to the compulsory assignment of real estate mortgages under certain circumstances, came from the House by that Branch referred to the committee on judiciary and on motion by Mr. Murphy of Cumberland, was tabled for printing pending reference in concurrence.

An Act to amend Section 70 of Chapter 8 of the Revised Statutes, as amended by Chapter 186 of the Public Laws of 1909, relating to the collection of inheritance taxes, came from the House by that Branch referred to the committee on judiciary, and on motion by Mr. Cole of York, was tabled for printing pending reference in concurrence.

The following bills came from the House, introduced in that Branch after the expiration of the time limit on private legislation:

An Act to amend Chapter 489 of the Private and Special Laws of 1901, entitled "An Act to supply the town of Lubec with pure water."

An Act to permit the town of Pitts-field to obtain a pure water supply.

An Act to incorporate the Pittsfield Water District.

The PRESIDENT: The Chair has been informed by a large majority of the members of the Senate that they are opposed to the suspension of the rule or the extension of the date for receiving private and special legisla-

tion. In order to relieve any individual member of the Senate from embarrassment—the Chair avaits himself of his own right of objection, and unanimous consent is denied and under the joint rules these bills are referred to the next Legislature.

An Act relating to the assistant assessors of the city of Portland, came from the House by that Branch referred to the Cumberland delegation, and on motion by Flaherty of Cumberland, the Senate non-concurred with the action of the House in referring this bill to Cumberland county delegation, and the bill was then referred to Portland delegation.

The following order came from the House, passed by that Branch and sent up for concurrence:

Ordered, the Senate concurring, that hereafter all resolves calling for financial aid in cities, towns and plantations, shall be accompanied by statement of facts, certified and sworn to by municipal and other officers having jurisdiction over the same to entitle them to the consideration of committees.

There was no objection and the senator presented the following report, which was read by the Chair:

The committee on salaries and fees which was instructed by an order of the Legislature to inquire into the expediency of appointing a special com. mittee to sit during the recess and after adjournment of the present session, and to inquire into the amount of compensation received by all State and county officers, whose salaries are determinable by the Legislature, and to report to the next Legislature such amounts as will make the salaries of such officers equitable throughout the State, have had the same under consideration, and ask leave to report the accompanying order relating to the salaries of officers.

(Signed) Wing for the Committee. The report was accepted.

Ordered, that a special joint committee of three on the part of the Senate and four on the part of the House, be appointed to inquire into the amount of compensation and services rendered by all State and county officials whose salaries are determinable by the Legislature. Said committee is hereby authorized to sit during any recess and after the adjournment of the present session, with

the full power to employ a stenographer, ort, summon, administer oaths to and examine witnesses, call for books and papers, and in general to obtain all of necessary information upon which may be based Legislative action looking towards equalization of salaries, and and report in writing their findings and recommendations, which report shall be filed with the clerk of the House not later than December 1, 1914, and be referred to the next Legislature without further action thereon.

On motion by Mr. Wing the report and accompanying order were tabled for printing pending adoption of the order.

On motion by Mr. Cole of York, An Act to amend Chapter 118 of the Private and Special Laws of 1911 relating to the park commissioners of the city of Portland, was taken from the table.

On further motion by the same senator, the bill was tabled for printing pending reference to the committee on judiciary in concurrence.
