SENATE.

Tuesday, January 19. 1915.

Senate called to order by the President at 10.30 A. M. according to adjournment.

Prayer by Rev. John Gibson of Augusta.

Journal of previous session read and approved.

Papers from the House disposed of in concurrence.

The following bills, petitions, etc., were presented and on recommendation of the committee on reference of bills were referred to the following committee:

Appropriations and Financial Affairs.

By Mr. HASTINGS of Androscoggin: Resolve in favor of the Hayes Young Women's Home of Lewiston for assistance in carrying on its work.

By Mr. BOYNTON of Lincoln: Resolve in favor of the Joint Special Committee on Salaries and Fees of the Seventy-sixth Legislature.

Judiciary.

By Mr. BURLEIGH of Aroostook: Bill, An Act to amend Chapter Six of the Revised Statutes, relating to the regulation and conduct of elections. (Ordered printed and referred.)

Legal Affairs.

Mr. HASTINGS of Androscoggin presented bill, An Act to repeal Chapter 221 of the Public Laws of the year 1913, entitled, "An Act to Provide for Nomination of Candidates of Political Parties by Primary Elections," and amendments thereto.

Workmen's Compensation Acts.

By Mr. Swift of Kennebec: Bill, An Act relative to compensation to employees for personal injuries received in the course of their employment and to the prevention of such injuries.

By Mr. COLE of York: Bill, An Act relative to compensation to employees for personal injuries received in the course of their employment and to ber, after the ninety days provided by the prevention of such injuries.

Ordered: The House concurring that a Joint Select Committee to be designated committee on the revision of the Statutes, be appointed, consisting of three on the part of the Senate and seven on the part of the House.

The PRESIDENT: The Chair wishes to state in this connection that at the last session of the Legislature, 1913, John A. Morrill, Esquire, of Lewiston and Auburn, was appointed a commissioner of this Legislature to revise the Statutes of Maine. He has made a report to this Legislature, which will be submitted in due time, of his revision, which is contained in the book you have before you. Following the procedure of the Legislature of 1903, which made the last revision of the Statutes, the Chair has examined the procedure there and finds that the order of procedure is this: A joint select committee on revision is appointed early in the session which consists of ten lawyers, three on the part of the Senate and seven on the part of the House, and they are a committee on revision of the statutes, and to that committee as soon as appointed is referred this report of this commissioner. It is the duty of the committee as soon as appointed to organize, and prepare the necessary bills and acts for carrying into effect the recommendations of the commissioner. That would be between fifty and one hundred bills which have to be drawn by the committee to carry out the provisions of the statutes. Those bills will be presented to this Legislature, go through the several Houses in due form and be enacted into law.

That committee also sits in vacation after the Legislature adjourns, under an order later passed, and incorporates into that revision the public laws of this Legislature. Then the Legislature is called into special session, probably sometime next Septemthe referendum are passed, and accepts the revision of the statutes.

> You should complete the organization of your committees and proceed with the work of the Legislature. We hope that every Senator will feel, as we have been delayed a good deal and now it is the 19th day of January, that we should get to work as soon as possible.
