#### SENATE.

#### Wednesday, Jan. 20, 1915,

Senate called to order by the President. Prayer by Rev. William H. Brokenshire of Hallowell.

Journal of previous session read and approved.

On motion by Mr. Emery of York unanimous consent was granted and that Senator presented the bond of Elmer E. Newbert. State Treasurer-elect. and asked for its immediate consideration.

The bond was referred to the committee on appropriations and financial affairs, and sent down for concurrence.

From the House: Ordered, That no bill or resolve carrying an appropriation of money shall be finally passed prior to the first day of March, 1915. (On motion by Mr. Emery of York, tabled pending reference)

From the House: Ordered, The Senate concurring, that no bill or resolve carrying an appropriation of money shall be introduced after the tenth day of February, 1915. (On motion by Mr. Swift of Kennebec, tabled pending reference.)

From the House: Ordered, The Senate concurring, that the time for the reception of petitions and bills for private and special legislation be limited to Wednesday, February 10th, 1915, and that all such petitions and bills presented after that date be referred to the next legislature, and that the Clerk of the House cause copies of this order to be published in all the daily papers in this State until February 1, 1915. (On motion by Mr. Clark of York, tabled pending reference.)

The report of the Maine School for Feeble Minded, to the committee on school for feeble minded; the report of the State Board of Health, to the committee on public health; the annual report of the Adjutant General, to the committee on military affairs; the report of the State Board of Charities and Corrections. to the committee on appropriations and financial affairs; the report of Insurance Commissioner, to the committee on mercantile affairs and insurance. Sent down for concurrence.

Mr. Emery from the committee on appropriations and financial affairs to which was referred the bond of Elmer E. Newbert, treasurer of State-elect, by unanimous consent, reported that same be approved by the legislature and deposited in the office of the secretary of State.

The report was accepted.

The bond was then accepted by the Senate and sent down for concurrence.

No act or resolve involving an appropriation of money, or amending a statute or resolve involving an appropriation of money shall be engrossed without having endorsed thereon, in addition to the usual endorsements of the officers of the Senate and the House, the following, viz:
