#### SENATE.

Friday, February 5, 1915.

Senate called to order by the President. Prayer by Rev. Harold W. Haynes of

Journal of previous session read and approved.

On motion by Mr. Hastings of Androscoggin, it was

Ordered, the House concurring, that when the Senate and House adjourn, it be to meet Tuesday forenoon, Feb. 9, at 10 o'clock.

The PRESIDENT: After consultation between the leaders of both Houses this joint order was presented for this reason, that under the rules of the reference committee all printing comes to the clerk of the House and the secretary of the Senate and is sent directly to the committees, and does not go through the legislature, so that meeting at 4 o'clock on Monday afternoon would not hurry matters any, as there is nothing for the legislature to consider except the reports of committees, and there are none that will be ready at that time.

The order was sent down for concurrence and the Senate was later informed that the House had adopted the order in concurrence.

Mr. BOYNTON of Lincoln: Mr. President, I rise to a question of personal privilege.

The PRESIDENT: The Senator state it.

Mr. BOYNTON: It is in connection with some remarks of mine last Wednesday.

(Unanimous consent was granted.)

Wednesday last I caused to be read into the record of this Senate some matters, extracts quoted from the remarks of the President and from the records of the Governor and Council. When I did that it was my intention, and my intention only, to add another act to the passing political comedy, as I so considered it, and without the slightest intention of humiliating anyone. Little at that time to the committee on library. did I dream that any one would so consider it. Doubtless had I given it a little the Senate non-concurred with the House more consideration I should not have in referring the resolve to the committee done it.

Now I want to say that I have known the President of the Senate ever since I first came here, and between him and myself has grown up a strong friendship, and I would sooner lose my right hand than that any intentional act of mine should cause him humiliation. admired him for his honesty, his integrity and his uprightness, and have looked forward to the time when I should leave this Senate and in my onward path through life look back with pleasure on my association with Ira G. Hersey.

To the members of this Senate,-many of you may take practically the same view, and you have some right to, that the President has taken,-but I asked of you unanimous consent to present a matter here which I thought I explained. but perhaps I did not.

I want to say to you that it was not my intention, it never will be my intention, to abuse the privileges which the Senators have granted me, or may hereafter grant me. I want to be fair to all, and I say this of my own free will, and as what I consider an act of justice. (Applause.)

The PRESIDENT: The Chair wishes to state that I know the sentiments of every senator present. we thank Senator Boynton for the frank, honorable way in which he has explained this matter. We feel that he has done justice to himself, justice to the President and justice to the Senate, and we all thank and honor him for it and consider the incident closed to the satisfaction of all.
