#### SENATE.

Thursday, February 25, 1915. Senate called to order by the President.

Prayer by Rev. Clayton Boothby of Augusta.

Journal of previous session read and approved.

On motion by Mr. Scammon of Hancock, by unanimous consent the rules were suspended, and that Senator presented Petitions of a number of persons from Bar Harbor for the opening of roads for the use of automobiles, and same were referred to the committee on judiciary and sent down for concurrence.

Papers from the House disposed of in concurrence.

From the House: An Act to incorporate the Mopang Dam and Improvement Company.

In the Senate this bill was passed to be engrossed and sent to the House for concurrence. In the House, House Amendment A was adopted and the bill as amended was passed to be engrossed.

The vote whereby this bill was passed to be engrossed in the Senate was reconsidered; House Amendment A was adopted, and the bill as amended was passed to be engrossed in concurrence.

The PRESIDENT: After the bill is passed to be engrossed it goes to the House, and then comes back here and you then have an opportunity to amend it.
