#### LEGISLATIVE RECORD -SENATE, MARCH 9.

#### SENATE.

Tuesday, March 9, 1915.

Senate called to order by the President.

Prayer by Rev. Wylie H. Smith of Hallowell.

Journal of previous session read and approved.

Papers from the House disposed of in concurrence.

On motion by Mr. Moulton of Cumberland, the rules were suspended and that Senator presented out of order the following Petitions which were referred to the committees on towns. Petition of L. H. Merrill and 54 others against An Act for the division of appropriation to complete the Histhe town of Cumberland; also petition of Earl L. Rose and others against the same.

From the House: An Act relative to the employment of minors.

In the House this bill was referred to the committee on labor. On motion by Mr. Burleigh of Aroostook, tabled for printing pending reference to the committee on labor.

The following bills, petitions, etc.. were presented, and on recommendation of the committee on reference of bills, were referred to the following committees:

#### Inland Fisheries and Game.

The reports were accepted and sent down for concurrence.

#### Passed to Be Engrossed.

House 302. An Act to provide for a closed time on bull moose. (On motion by Mr. Peacock of Washington, tabled pending its passage to be engrossed, and Friday, March 12, specially assigned for its consideration.)

House 357. An Act to amend Section 20 of Chapter 67 of the Revised Statutes, relating to the distribution of personal estate.

House 377. An Act prohibiting the rebating of premiums on fire or liability insurance.

House 376. An Act requiring that adjusters of fire losses be licensed.

House 378. An Act to amend Chapter 64 of the Public Laws of 1913, relating to the qualification of insurance agents and brokers.

House 391. An Act to amend Section 55 of Chapter 79 of the Revised Statutes, relating to the fixing of the time within which exceptions and motions for new trials may be filed in civil and criminal cases.

House 404. An Act to amend Section 11 of Chapter 116 of the Revised Statutes, as amended by Chapter 53 of the Public Laws of 1905, as further amended by Chapter 183 of the Public Laws of 1907, as further amended by Chapter 118 of the Public Laws of 1909, relating to the compensation of members of the Legislature. (On motion by Mr. Boynton, tabled pending its passage to be engrossed. Subsequently, on motion by the same senator, the bill was taken from the table and passed to be engrossed. Subsequently, on motion by Mr. Walker of Somerset, the vote whereby the bill was passed to be engrossed was reconsidered; and on further motion by the same senator the bill was retabled and specially assigned for consideration on Friday morning, March 12.)

House 445: An Act to amend Section one of Chapter 61 of the Private and Special Laws of 1891, relating to Limerock Railroad Company.

House 448: An Act to amend the Charters of the Thomaston Street Railway Company, the Rockland Street Railway Company and the Camden & Rockport Street Railroad Company, and conferring certain additional rights, powers and privileges on said company.

House 461: Resolve providing a state pension for Alonzo J. Nevers.

House 462: An Act providing for pensions for employees of the City of Bangor.

House 463. Resolve providing a state pension for Eliza E. Philbrook.

House 464. Resolve providing a state pension for Clarence M. Smith.

House 465: Resolve providing a state pension for Lucy A. Owens.

House 466: Resolve providing a state pension for Mary Allen. (House amendment "A" adopted in concurrence. House Amendment A to House Document No. 466: "Amend by striking out the word 'three' in the first line, and inserting after the word 'hundred' in the second line the words 'ninetytwo'.)"

House 467: An Act to amend Section one of Chapter 44 of the Revised Statutes as amended by Section three of Chapter 116 of the Public Laws of 1913, relating to local sealers of weights and measures.

House 468: An Act to consolidate sections 14 and 38 of chapter 40 of the Revised Statutes relating to the penalty for unlawful use of containers marked with registered devices, and to amend Section 39 of said Chapter relating to search warrants therefor.

House 469: An Act to amend Section six of Chapter 44 of the Revised Statutes, providing a penalty for neglect of duty by local sealers of weights and measures.

Senate 238: An Act to amend the Military Laws.

Mr. Boynton of Lincoln presented Senate Amendment A to Senate Document 238 and moved its adoption.

Senate Amendment "A" to Senate 238:

"Amend Section 45 of Chapter 206 of the town of Milbridge. the Public Laws of 1909 by striking out all of said Section after the word 'for' in the eighth line and substituting therefor the following: 'Each division commander shall be allowed a sum not exceeding \$50 per annum for the care and responsibility of public property for which he is accountable; the executive officer of the ship's company, each division clerk and the third class of veomen of each division shall receive for their services a sum not exceeding \$25 dollars per annum.' So that said section as amended shall read as follows

"'Section 45: The pay of officers and petty officers of the naval reserve shall be the same as that of officers and noncommissioned officers of the same relative rank in the national guard; and seamen shall receive the pay of privates of infantry. The cammanding officer of the ship's company shall be allowed a sum not exceeding \$50 per annum for the care and responsibility of such state and United States property as he may be accountable for; each division commander shall be allowed a sum not exceeding \$50 per annum for the care and responsibility of public property for which he is accountable the executive officer of the ship's company, each division clerk and the third class yeomen of each division shall receive for their services a sum not exceeding \$25 per annum.' "

The bill was then passed to be engrossed as amended.

Senate 258: Resolve in favor of the Commissioners of Pharmacy for equipment and also for the liquidation of certain deficiencies.

Senate 263: An Act relative to the hours of labor of employees of Street Railway Companies. (On motion by Mr. Emery of York, tabled pending its passage to be engrossed, and specially assigned for consideration on Wednesday, March 17.)

Senate 264: An Act to authorize the Municipal Light & Power Company to decrease its capital stock.

Senate 265: An Act to amend, revive and extend the charter of the Stratton Water company.

Senate 266: An Act authorizing the building and maintaining of a dyke in

On motion by the same Senator, report of the committee on pensions, ought not to pass, on Resolve providing a state pension for Francis H. Orrok, was taken from the table, and on further motion by the same Senator the report and resolve were recommitted to the committee and sent down for concurrence.

On motion by Mr. Herrick of Franklin, report of the committee on wavs and bridges, ought not to pass, on resolve in favor of Sandy River Plantation for building a bridge, was taken from the table, and on further motion of the same Senator the report and resolve were recommitted to the committee.
