SENATE.

Saturday, March 13, 1915.

Senate called to order by the President.

Prayer by Rev. B. P. Hope of Aufusta.

Journal of previous session read and approved.

On motion by Mr. Herrick of Franklin (under suspension of the rules) it was

Ordered, the House concurring, that when the Senate and House adjourn it be to meet at 10 o'clock Tuesday forenoon, March 16, 1915.

Sent down for concurrence. Subsequently the Chair informed the Senate that the House had concurred in the passage of the order.

(Senator Boynton in the Chair.)
Papers from the House disposed of in concurrence.

From the House: Senate 151, An Act to equalize the salaries of the judges of probate.

In the Senate, Senate amendment A was adopted and sent down for concurrence. The House adopted the amendment in concurrence and also adopted House amendment A.

In the Senate the question was on the adopttion of House amendment A.

Mr. ALLEN of Kennebec: Mr. President, the Senator from Oxford being absent, I believe it would be only justice to table this matter for his consideration before accepting it, and I so move.

The motion was agreed to and the bill tabled and assigned for next Tuesday.

From the House: Resolve in favor of monuments in memory of Benedict Arnold's expedition through Maine.

In the House the bill was indefinitely postponed.

On motion by Mr. Allen of Kennebec the report of the committee of the resolve was tabled pending acceptance and assigned for next Tuesday.

Mr. HERSEY of Aroostook: Mr. President, regarding the statement of the committee on engrossed bills that no statement of fact accompanies the resolve, I will say that resolves for carrying on the government do not require any statement of facts. I noticed one this morning-House Document No. 555, "Resolve providing an epidemic or emergency fund"-was tabled by the senator from Kennebec, Senator Swift. It should not have been tabled. It should go on, unless there is some other objection.

Mr. SWIFT of Kennebec: I will say that I tabled that bill at the request of the clerk of the committee on bills in the second reading. I have no personal interest in it in any way.

Mr. HERSEY: He wanted it tabled because there was no statement of facts -is that the reason?

Mr. SWIFT: Yes.

Mr. HERSEY: It should not be tabled for that.

Mr. FULTON of Aroostook: I would just say that when that bill came before the committee on public health, as it was an appropriation made every two years for an emergency fund for carrying on the government, we saw no reason why it would require any statement of facts, and so we didn't require it to be placed on it.

Mr. SWIFT: Mr. President, in view of the statement of the senator from Aroostook, Senator Hersey, I will withdraw my motion, or move to reconsider it, whatever is the proper parliamentary procedure.
