#### SENATE.

Saturday, March 20, 1915.

Senate called to order by the President.

Hallowell.

Ordered, that a message be sent to the Governor requesting the return to the Senate of An Act establishing a reformatory for women, for further consideration.

The Secretary conveyed the message and subsequently reported that he had delivered the message with which he was charged; that the papers were not in the possession of the Governor but would be immediately transmitted to the Senate.

Papers from the House disposed of in concurrence.

From the House: Report of the committee on legal affairs on An Act requiring vehicles to carry lights at night on public highways.

In the Senate this bill was indefinitely postponed in concurrence with the House.

Subsequently the House reconsid. ered its action and adopted House Amendment A and sent it up for concurrence.

Mr. ALLEN of Kennebec: Mr. President. 1 know that Senator Walker was very much opposed to the passage of this bill, and I do not know but that it would be fair to lay that it be tabled and assigned for next Tuesday.

The motion was agreed to.

The PRESIDENT: The Chair lays Prayer by Rev. W. F. Livingston of before the Senate An Act to establish a State reformatory for women. The Chair would like to state that this act has unanimously passed both Houses and has been signed by the Speaker and the President and then went to the Governor for his approval.

The Senate will remember that day before yesterday Senator Murphy sage to the Governor requesting the return of this bill for the purpose of Subsequently the Chair informed amending it. The Senate refused to the House sent an order to the Governor requesting the return of the paper, and I am not aware of any further action.

> Yesterday the leaders of hoth Houses practically agreed that certain formal amendments to the bill ought to be made; and they agreed to ask unanimous consent this morning in both Houses that this act might be returned to the Senate, and the Senate reconsider and its action adopt the amendments, if it pleases, and send it to the House for concurrent action, and have the bill amended repassed, so to speak.

> Now the matter is before us at the present time and the papers are in the possession of the Senate.

> On motion by Mr. Allen of Kennebec, by unanimous consent the vote whereby this bill was passed to be enacted was reconsidered.

> On further motion by the same Senator, by unanimous consent, the vote was reconsidered whereby this bill was passed to be engrossed.

> On further motion by the same Senator, Senate Amendment A to this bill. Senate 215, was adopted.

> "Senate Amendment A to Senate Bill 215.

"Amend by adding after the word 'years' and before the word 'and' in the sixth line of Section 2, the following: 'subject to removal by the Gov. ernor and Council, for cause,' so that it on the table until Tuesday. I move said section as amended shall read as follows: 'Section 2. Immediately after the passage of this act, the Governor shall, with the advice of the Council, appoint five persons, of whom at least two shall be women, all of whom shall be inhabitants of this State, to be trustees of such reformatory. The terms of office of such trustees shall be five years, subject to removal by the Governor and Council, for cause, and they shall be so appointed that the term of one of them shall expire on the first Tuesday of February in each year. Anv person appointed to fill a vacancy in the board of trustees shall hold office for the remainder of the term of the person whom he or she succeeds.""

On further motion by the same Senator, Senate Amendment B to Senate Document 215 was adopted.

"Senate Amendment B.

"Amend Senate Document 215, An Act to establish a State reformatory for women by striking out the words 'a sum of money not exceeding,' in the first line of Section 20, so that said Section as amended shall read as follows:

'Section 20. Twenty thousand dollars shall be appropriated under this act to be used and expended for the purposes herein named during the years 1915, and the sum of thirty thousand dollars during the year 1916.'"

On further motion by the same Senator the bill as amended was passed to be engrossed and sent down for concurrence.
