HOUSE.

Tuesday, January 23, 1917.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Dow of Gardiner.

Journal of previous session read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: Ordered House concurring, that an invitation be extended to the Honorable Lyman H. Nelson of Portland, formerly chairman of the State Highway Commission, to address the Legislature and the citizens of Maine upon the subject of State Highways on the evening of Wednesday, January 24th, 1917, at eight o'clock; and be it further ordered that the Hall of the House of Representatives be devoted to this purpose on this occasion.

On motion by Mr. Allan of Portland, the order was tabled pending concurrence.
