### HOUSE.

#### Wednesday, January 31, 1917.

#### Orders of the Day.

Mr. SISSON of Island Falls: Mr. Speaker, although I am proud to be a resident of the State of Maine, I discovered this morning that I am from Missouri, I have got to be shown. This morning a card was placed on my desk as well as on the desks of all members of the House, stating that in order to facilitate and expedite business, and to have a uniform rule in regard to amendments, the President of the Senate and the Speaker of the House will entertain no amendments to any bill or resolve until the same has been read twice in the Senate and three times in the House. The SPEAKER: The Chair will inform the gentleman from Island Falls (Mr. Sisson) that the President of the Senate and the Speaker of the House are of the opinion that the cards as printed are not readily understood by the two houses, and the matter will be presented at a later session.

Mr. Harman then offered the following amendment:

House Amendment A to order relating to expenditures incurred by State Highway Commission.

Amend said order by inserting the words "the Senate concurring" after the word "Ordered", in the first line of the order, so that the same shall read as follows:

"Ordered, the Senate concurring, that the State Highway Commission file with the Legislature forthwith an itemized statement of all expenditures incurred by it during the past two years. which statement shall include particularly and in detail the amount expended in actual road construction exclusive of surveys, inspection, salaries, etc., as well as a detailed statement of all other expenditures.

The order then received a passage as amended.

Mr. DUTTON Bingham: of Mr. Speaker, I wish at this time to take from the table Senate Doc. No. 25, Act relative to horseshoeing, tabled by me Friday. I desire to state that I feel perhaps that it would be courteous to refer this measure to the committee as it may be possible for the proponents of the measure to offer some evidence in justification of a portion of it. I am also requested by Senator Gillin of Bangor to state that he is not the parent of this bill. He wishes to state that the bill was handed by a constituent to the President of the Senate. and the President of the Senate requested Senator Gillin to introduce it. Senator Gillin wishes this statement made because he does not wish to be criticised for any future stand he may make in regard to the measure; and I move that we concur with the Senate in the reference of the bill to the committee on legal affairs.

The House then concurred with the Senate in the reference of the bill to the committee on legal affairs.

No 44, An Act to repeal Section 73 of Chapter 33 of the Revised Statutes, relating to Sunday being a closed season for game or birds, was taken from the table and on further motion by the same gentleman, was referred to the committee on inland fisheries and game.
