The House met according to adjournment and was called to order by the Speaker.

Orders of the Day.

On motion by Mr. Emerson of Lewiston, unanimous consent was given, and that gentleman introduced, out of order at the present time, bill, "An Act to incorporate the Peat Powder Producing Company," and, on further motion by the same gentleman, the bill was referred to the committee on legal affairs.

On motion by Mr. Sawyer of Madi-Robin Hill in said town," and, on further motion by the same gentleman, the resolve was referred to the committee on ways and bridges.

On motion by Mr. Ellis of York, unanimous consent was given, and that gentleman introduced, out of order at the present time, bill, "An Act to incorporate the York Beach Chamber of Commerce," and, on further motion by the same gentleman, the bill was referred to the committee on legal affairs.

PURINGTON of Mechanic Falls: Mr. Speaker, if it is in order, I will move to reconsider the vote whereby the House passed to be engrossed House Bill No. 362, bill, "An Act to permit savings banks to invest in certain railroad bonds." The bank examiner spoke to me a day or two ago, and said that the bill needed some amendment and that he would prepare the amendment and give it to me, but he has not done so.

On motion by the gentleman from Mechanic Falls (Mr. Purington) the House reconsidered its vote whereby House Document No. 362 was passed to be engrossed, and, on further motion by the same gentleman, the bill was tabled pending its passage to be engrossed.

Mr. Clarke of Randolph presented out of order, under suspension of the rules, the following order and moved its passage: "Ordered, the Senate concurring, that 300 extra copies of Senate Bill No. 185 be printed for the use of the House and Senate."

The order received a passage.

Mr. BARNES of Houlton: Mr. Speaker, there is in the Clerk's possession, it having been recalled from the committee on judiciary, a bill, introduced early in the session, entitled "An Act relating to widows' allowance," and I move that 500 copies of the same be printed.

The motion was agreed to.

On further motion by the same gentleman, the bill was recommitted to the committee on judiciary.

On motion by Mr. Cole of Eliot, the rules were suspended to consider out of order the following Senate Report on the order of the Senate, January 31, 1917, which read as follows:

"Ordered: that the Superintendent of Buildings be and hereby is instructed to procure and have placed above the President's chair in the Senate Chamber a suitable coat of arms of State of Maine appropriately draped at a cost not exceeding five hundred dollars; and ordered further that a special committee of three, consisting of the President of the Senate and two other members of the Senate, be appointed by him to act with the Superintendent of Buildings in making any arrangements for suitable design, contract for said coat of arms and hangings, and see that the same is put in place as soon as possible."

In the Senate, the committee on public buildings and grounds to which was referred this order, reported resolve entitled, "Resolve providing the sum of \$500 for a coat of arms of the State of Maine for the Senate Chamber."

Came from the Senate, read and accepted.

In the House, accepted in concurrence, and under a suspension of the rules, the resolve was given its two several readings and passed to be engrossed.

Mr. SNOW of Mars Hill: Mr. Speaker, I wish to say a word or two. I would not like to shut anybody off from introducing private bills, and I think perhaps some of those introduced this morning come in properly at this time; but we ought to establish a limit somewhere when this thing should stop. Two weeks ago there was a time limit set for private and special bills to be introduced which was advertised by the clerk ir all the newspapers of the State, and it seems time now that we should insist upon the action that we then took. There are more than 300 bills advertised in the Kennebec Journal for hearing this morning. As many, or more, are in the hands of committees to be heard, besides a lot of others they have had hearings upon but have not reported on. We have spent eight

weeks now in this legislative session and it seems time that we get a hustle on.

The SPEAKER: The Chair would suggest that the opposition of one member will stop the introduction of any bill at any time. The remarks of the gentleman from Mars Hill, Mr. Snow, would have been appropriate at the time of the introduction of these measures this morning when the motion was before the House. However, I trust what he has said may have a salutary effect.

The SPEAKER: The Chair lays before the House as a matter of unfinished business, House report of the committee on inland fisheries and game, nish. reporting "ought not to pass" on House Doc. 48, entitled "An Act to amend morning, February 27.

Section 22 of Chapter 33, Revised Statutes, relating to the unlawful selling or purchasing of fish", tabled, February, 21, by the gentleman from Eliot, Mr. Cole, pending acceptance of the report.
