SENATE.

Thursday, January 18, 1917. Senate called to order by the Presi-

dent. Prayer by Rev. Wylie H. Smith of Gardiner.

Journal of previous session read and approved.

On motion by Mr. Deering of York, under suspension of the rules it was

Ordered, the House concurring, that when the Senate and House adjourn they adjourn to meet Tuesday, January 23, at ten o'clock in the forenoon.

Subsequently the order came back from the House, concurred in by that body.

Mr. HIGGINS: Mr. President, in order that the Senators may be familiar with my purpose in offering the amendment, I would state that it is the desire of the Governor that we do not adjourn today, in order that we may catch up with our work and hasten matters so that an adjournment may be finally taken at an earlier date than otherwise. For that reason I ask for reconsideration of the order.

The motion was agreed to.

Mr. HIGGINS: Mr. President, I now offer the following amendment: Amend by inserting after the word "adjourn," the word "Friday."

The PRESIDENT: The motion is not necessary as we would adjourn until tomorrow anyway.
