SENATE.

Thursday, March 1, 1917.

Senate called to order by the President.

Prayer by Rev. W. F. Livingston of Hallowell.

Journal of previous session read and approved.

Papers from the House disposed of in concurrence.

From the House: Remonstrances of Charles Roy and 27 others; of Joseph Delorne and 62 others; of Joseph Levesque and 8 others, against the passage of the Lewiston Police Commission bill unless it contains the referendum clause

In the House referred to the committee on judiciary.

In the Senate on motion by Mr. Davies of Cumberland, placed on file in non-concurrence.

House Bills in First Reading.

H. D. 362. An Act to permit savings banks to invest in certain railroad bonds.

H. D. 199. An Act to amend Section 107 of Chapter 52 of the Revised Statutes relating to loans by loan and building associations.

H. D. 273. An Act to establish the Presque Isle municipal court. (On motion by Mr. Stanley of Oxford, tabled pending assignment for second reading.)

H. D. 400. An Act to provide a police commission for the city of Lewiston and to promote the efficiency of the police department thereof. (On motion by Mr. Higgins of Penobscot the rules were suspended and the bill was given its second reading and was passed to be engrossed, in concurrence.)

House 381. An Act to amend Section 31 of Chapter 3 of the Revised Statutes, so as to provide for a maximum number of annual reports of the public utilities commission.

House 382. An Act additional to Chapter 51 of the Private and Special Laws of 1907, relating to the pollution

of the waters of North, or Varnum's pond.

House 384. Ar. Act to extend the charter of the North Bridgton Village Corporation.

House 385. An Act to amend Chapter 132 of the Private and Special Laws of 1913, relating to the ferry between Indian Island, so-called and the city of Old Town.

House 286. An Act to amend Section 28 of Chapter 64 of the Revised Statutes, relating to registration of vital statistics.

House 387. An Act relating to the jurisdiction of the municipal court of Dexter.

House 388. An Act amendatory of the existing law relating to review by the supreme judicial court of certain orders, decrees and decisions of the public utilities commission.

House 389. An Act providing for court jurisdiction in criminal cases originating in Hibbert's Gore.

House 390. An Act to amend Chapter 239 of the Private and Special Laws of 1913, relative to Lincoln municipal court, giving the recorder of said court authority to issue warrants upon complaints for criminal offenses.

House 393. An Act to give more power to the local sealers of weights and measures and their deputies.

House 391. Resolve in favor of Freeman Boynton of Boothbay Harbor, in the county of Lincoln, for refund of money paid in lieu of military service in the late war of the Rebellion.
