Wednesday, January 22, 1919.

The following bills, resolves, etc., were presented, and on recommendation of the committee on reference of bills, were referred to the following committees:

Appropriations and Financial Affairs.

By Mr. Grant of Cumberland, Resolve appropriating money to carry on the work of a State Board of Children's Guardians.

By Mr. Gannett of Kennebec, Resolve appropriating money to carry on the work of the State Board of

Mother's Aid as defined by Chapter 222 of the Public Laws of 1917 and amendments thereof.

By Mr. Thornton of Aroostook, Resolve in favor of the Northern Maine General Hospital, Eagle Lake, for the care, support and medical or surgical treatment of indigent persons, and for other purposes.

By Mr. Grant of Cumberland, Resolve appropriating money to carry on the work of the State Board of Charities and Corrections as defined by Chapter 147 of the Revised Statutes and amendments thereof.

Education.

By Mr. Walker of Somerset, An Act to amend Section 2 of Chapter 16 of the Revised Statutes, relative to school conveyance. (500 copies ordered printed.)

Judiciary.

By Mr. Deering of York, An Act to supplement Chapter 29 of the Revised Statutes and to provide for the care of persons requiring full support or more than temporary relief. (1000 copies ordered printed.)

By Mr. Dearth of Penobscot, An Act in relation to the acts or omissions of a child more than seven years of age and under 16 years of age. This Act to be known and styled as the "Act of Juvenile Delinquency." (500 copies ordered printed.)

Legal Affairs.

By Mr. Parent of Androscoggin, An Act to amend Section 15 of Chapter 12 of the Revised Statutes, relating to indexes in the registries of deeds.

By Mr. Folsom of Somerset, An Act to amend Chapter 485 of the Private and Special Laws of 1901 as amended by Chapter 331 of the Private and Special Laws of 1909, relating to Western Somerset Municipal Court.

Library.

By Mr. Metcalf of Piscataquis, An Act to amend Section 42 and 43 of Chapter 64 of the Revised Statutes relative to the publication of ancient vital statistics.

Military Affairs.

By Mr. Metcalf of Piscataquis, An Act amending Chapter 205 of Private and Special Laws of 1911 relating to

annual report of the Grand Army of the Republic of the State of Maine.

By Mr. Gannett of Kennebec, Resolve appropriating money to provide offices for the Adjutant General's Department and fireproof apartment for the records and documents thereof.

Salaries and Fees.

By Mr. Googin of Androscoggin, An Act to amend Chapter 117, Section 42 of the Revised Statutes, as amended by Chapter 39, 167 and 173 of the Public laws of 1917, relating to the compensation of county commissioners.

By Mr. Grant of Cumberland, An Act to amend Section 2 of Chapter

14 of the Revised Statutes relating to the State Board of Charities and Corrections as amended by Chapter 80 of the Public Laws of 1917.

Ways and Bridges.

By Mr. Davies of Cumberland, Resolve relating to the erection of a memorial bridge in Cumberland county to be known as "Maine's Memorial Bridge," and to be dedicated to those who gave much, and to those who gave all, that this Nation might live.
