SENATE

Wednesday, January 29, 1919.

Senate called to order by the President.

Prayer by Rev. H. S. Dow of Gardiner.

Journal of previous session read and approved.

Papers from the House disposed of in concurrence.

From the House: Ordered, the Senate concurring, that a joint committee of three on the part of the House, with such as the Senate may join, be appointed by the Chair to prepare and submit resolutions expressing appreciation of the courtesy of the Chief Executive in making the members of the Legislature his guests at the recent Efficiency Conference.

The Chair appointed as such committee, on the part of the Senate, Messrs. Gurney of Cumberland, Ames of Washington and Metcalf of Piscataquis.

From the House: Whereas that veteran unit, the 26th Division, popularly known as the "Yankee Division," is about to return to the New England it has loved and honored, be it

Resolved, That mindful of the valorous record, appreciative of the heroic deeds, conscious of the imperishable fame and slightly expressive of the unutterable pride and love of the people of Maine for the sons of this State, both those who have given and those who have offered their all that just freedom might endure, there be named a delegation consisting of His Excellency, the Governor of this State, the living ex-governors, the President of the Senate and Speaker of the House, the chief justice, the adjutant general of this State, and that this delegation be charged to meet and welcome in behalf of the people of Maine their returning sons upon their arrival at Boston.

This resolution came from the House adopted by that body.

Subsequently the Chair announced that the appointment of the committee would be in order tomorrow morning.
