SENATE

Tuesday, February 18, 1919. Senate called to order by the President.

Prayer by the Rev. P. J. Winslade of Gardiner.

Journal of previous session read and approved.

Papers from the House disposed of in concurrence.

House Bills in First Reading

H. D. 131: An Act to amend Paragraph 1 of Section 57 of Chapter 16 of the Revised Statutes, as amended by Chapter 188 of the Public Laws of 1917 relative to the payment of state aid to superintendents of unions in towns.

H. D. 137: Resolve in favor of fish screen at the outlet of Sebago lake.

At this time the President invited former President of the Senate, Taber D. Bailey, to take a seat by his side.

The following bills, resolves, etc., were presented and on recommendation of the committee on reference of bills were referred to the following committees:

Banks and Banking

By Mr. Baxter of Sagadahoc, An Act to amend Section 33 of Chapter 52 of the Revised Statutes of Maine, relative to deposits by savings banks in institutions outside of the State of Maine.

Judiciary

By Mr. Deering of York, An Act to amend Section 1, Chapter 84 of the Revised Statutes in relation to the appointment of clerks of the judicial courts.

Legal Affairs

By Mr. Thornton of Aroostook, An Act to amend Section 42 of Chapter 82 of the Revised Statutes, relating to the Law Court.

Salaries and Fees

By Mr. Creighton of Knox, An Act to amend Section 39 of Chapter 117 of the Revised Statutes, increasing the salary of the register of probate for Knox county.

By the same senator, An Act to amend Section 38 of Chapter 152 of the Public Laws of 1917, relating to the compensation of judges of probate.

By Mr. Davies of Cumberland, An Act to amend Section 32 of Chapter 117 of the Revised Statutes, as amended by Chapter 183, Public Laws of 1917, relating to the salaries of the Board of State Assessors, and for clerk hire in said office.

By Mr. Thombs of Penobscot, An Act to amend Section 40 of Chapter 117 of the Revised Statutes, relating to salaries.

By the same senator, An Act to amend Section 45 of Chapter 117 of the Revised Statutes, relating to clerk hire in the office of clerk of courts of Penobscot county.

Taxation

By Mr. Davies of Cumberland, An Act to amend Section 3 of Chapter 253 of the Revised Statutes, to provide for the collection of delinquent taxes.

By the same senator, An Act to amend Section 16, Chapter 9 of the Revised Statutes, to provide for inventory of exempt live stock, etc.

The report was accepted and sent down for concurrence.

Mr. Parent for the committee on legal affairs, on An Act to amend Chapter 120 of the Private and Special Laws of 1899, establishing a Livermore Fails municipal court, reported same ought to pass.

Mr. Peacock for the committee on ways and bridges, on An Act to amend Chapter 287 of the Public Laws of 1917, relating to registration of motor vehicles, reported same ought to pass.

The reports were accepted and the bills tabled for printing under the joint rules.
