SENATE

Tuesday, March 25, 1919.

Senate called to order by the President.

Prayer by the Rev. E. S. Philbrook of Augusta.

Journal of previous session read and approved.

On motion by Mr. Gannett of Kennebec, by unanimous consent, the rules were suspended and that senator presented the following committee report out of order:

The special committee to which referred the communication was from the Governor relating to the residence of the late James G. Blaine, with the accompanying deed and letter, have had the same under consideration, and ask leave to report the accompanying resolve, entitled, Resolve accepting the gift of the home of the late James G. Blaine, from his daughter, Harriet Blaine Beale, in memory of and the in name of her son, Lieutenant Walker Blaine Beale.

The Resolve was read by the secretary: :

Resolved: That the State accepts in trust the deed from Harriet Blaine Beale of the home of her father, Hon. James G. Blaine, in memory of and in the name of her son, Lieutenant Walker Blaine Beale, who fell fighting in France on the 18th day of September, 1918, and pledges its honor faithfully to fulfill the trust and to carry out with scrupulous care the directions and desires set forth in the deed and in the letter which accompanied it.

That the State hereby records its deep appreciation and its enduring gratitude for this gift which, in the complete satisfaction of a present need of the State, has a large and readily measured value, and also has even a greater value in those unseen and eternal things which make it priceless. For it will always speak to us of the heart of woman with its generosity, pure and tender sentiment and love of home: of the ever widening and abiding influence of a man of winning personality, persuasive speech, profound thought, broad grasp and prophetic vision; of the burning zeal of youth, its quick response to noble family tradition, and that flaming patriotism which offers and gives the "last full measure of devotion."

And be it further Resolved that being confident that the people of Maine desire that the last resting place of him, whose home it was and whose career brought such distinguished honor to the State, should be in the Capital, where that career began, and as an expression of our gratitude for his services to us and of our deep respect for his memory. the State hereby requests of his family the privilege of bringing from Washington the remain; of himself and his beloved wife and of placing them in the family lot. near Forest Grove cemetery, in Augusta, and of erecting thereon, with the approval of the family, an appropriate memorial.

That the Governor and Council be authorized and directed to take such action as may be necessary to carry into effect the purpose of this resolve and to pay the expenses thereof out of any money in the treasury not otherwise appropriated.

The report was accepted, and on further motion by Mr. Gannett, the rules were suspended, and the resolve was given its two readings and was passed to be engrossed and sent down for concurrence.

Mr. Gannett for the committee on military affairs, on Resolve to authorize and instruct the Governor and Council to erect a statue in memory of the sons of Maine who served in the World War, reported that the same be referred to the next Legislature, and that the Governor and Council be authorized and instructed to procure designs and plans for and estimates of cost of a memorial statue with tablets and base or pedestal such as described in said resolve and to report the same to the next Legislature.

Mr. Walker for the committee on temperance. on An Act to amend Section 17 of Chapter 127 of the Revised Statutes, relating to the manufacture of intoxicating liquor (House No. 383), reported same ought not to pass.

The reports were accepted and sent down for concurrence.

Passed to Be Engrossed

H. D. 71: An Act for the protection of clams within the limits of the Capitol Island Village Corporation in the county of Lincoln.

H. D. 453: An Act amendatory of and additional to Chapter 197 of the Public Laws of 1917, and Chapter 301 of the Public Laws of 1917, relating to the state department of health.

H. D. 454: An Act to amend Sec-

tions 1, 2, 3 and 4 of Chapter 297 of the Private and Special Laws of 1907, relating to the Fort Kent Village Corporation.

H. D. 456: An Act to enlarge the powers of trust companies.

H. D. 457: An Act to amend paragraph 1 of Section 7 of Chapter 19 of the Public Laws of 1917, relating to industrial banks.

H. D. 458: An Act to amend Section 44 of Chapter 14 of the Revised Statutes, relative to the sale of timber on Indian Township.

H. D. 460: Resolve, in favor of Esther M. Giles of Boothbay, for State aid.

S. D. 235: An Act to amend Section 71, Chapter 8 of the Revised Statutes relative to the office of forest commissioner. (On motion by Mr. Ames of Washington, tabled pending second reading.)

S. D. 239: An Act to amend Section 32 of Chapter 117 of the Revised Statutes as amended by Chapter 133, Public Laws of 1917, relating to the salaries of the board of state assessors and for clerk hire in said office. (On motion by Mr. Folsom of Somerset, tabled pending second reading.)

S. D. 243: An Act providing for the payment of half salary to judges of probate on retirement at seventy years of age, having served as such judge twenty consecutive years at least. (On motion by Mr. Grant of Cumberland, tabled pending second reading.)

S. D. 244: An Act to amend Section 42 of Chapter 82 of the Revised Statutes, relating to the law court.

S. D. 245: An Act to provide for the fixing of salaries and wages of subordinates of the several departments of the state government.

S. D. 247: An Act relative to the surety bond business of trust companies and domestic corporations, and amending Section 90 of Chapter 52 of the Revised Statutes. (On motion by Mr. Lord of York, tabled pending second reading.)

S. D. 248: An Act in addition to Chapter 52, Section 2, of the Revised Statutes, relating to the definition of banking.

An Act to amend Section 65 of Chapter 142 of the Revised Statutes, relating to the care of Children of women committed to the reformatory for women.

An Act to amend Section 40 of Chapter 127 of the Revised Statutes, relating to prosecutions, how commenced and conducted.

An Act to amend Paragraph 7 of Section 55 of Chapter 91 of the Revised Statutes relating to trustee process.

An Act to regulate the taking of smelts and tomcods in the waters of Whitten Parritt stream, in the town of Gouldsboro, in Hancock county, Tunk stream and all waters tributary to Steuben bay and Joys bay, above Lobster Island narrows in the town of Steuben, in Washington county.

An Act granting to women the right to vote for Presidential electors.

An Act to amend Section 39 cf Chapter 55 of the Revised Statutes, relating to increase or decrease of capital stock, or stock, bond or scrip dividend.

Today Assigned

The PRESIDENT: The Chair lays before the Senate H. D. 235, An Act relating to Martin's Point bridge, socalled, in the county of Cumberland, tabled by the senator from Cumberland, Senator Gurney, the pending question being the adoption of House Amendment A in concurrence.

On motion by Mr. Gurney the vote was reconsidered whereby this bill was passed to be engrossed, and on further motion by the same senator House Amendment A was adopted in concurrence, and the bill as amended was passed to be engrossed.

The PRESIDENT: The Chair lays before the Senate S. D. 205, Resolve for the laying of the county taxes for the year 1920, tabled by the senator from Cumberland Senator Gurney, pending question its passage to be engrossed as amended by House Amendment A.

Mr. GURNEY: Mr. President, I yield to the senator from Cumberland, Senator Grant.

On motion by Mr. Grant, the bill was tabled.

Orders of the Day

Mr. GANNETT of Kennebec: Mr. President, 1 have a resolution 1 wisn to offer and move its adoption.

The secretary read the resolution:

WHEREAS, the 26th Division is about to be given an official reception upon its return at the port of debarkation in Boston, and

WHEREAS, this Legislature has expressed its sense by prior resolution that an official committee of welcome be named to greet in behalf of the State of Maine, these returning heroes, and

WHEREAS, a great amount of detail is necessary to be arranged in order that the relatives of returning members of this unit may be afforded every facility to observe the demonstration planned in their behalf,

Now, Therefore, Be it Resolved, that there be named two members of the Senate by the President thereof, and three members o^{*} the House of Representatives by the Speaker thereof, to serve as an executive committee in comjunction with the aforesaid official com-

mittee above named in the arrangement of details for the facilitating opportunities on the part of the relatives and friends of the Maine members of this unit for participating in the aforesaid official demonstration soon to be held in Boston, Commonwealth of Massachusetts, and be it further resolved, that such expenses as are incurred by this committee be taken from the regular appropriation for legislative expenses.

The resolution was adopted and sent down for concurrence.

Mr. THOMBS of Penobscot: Mr. President, I move we take from the table H. D. 214, An Act to amend Section 86 of Chapter 33 of the Revised Statutes, as amended by Chapters 219 and 244 of the Public Laws of 1917, relating to the disposition of money collected under the provisions of the inland fish and game laws.

The motion was agreed to, and the senator from Penobscot, Senator Thombs, yielded to the senator from Piscataquis, Senator Metcalf.

On motion by Mr. Metcalf, the vote was reconsidered whereby this bill was passed to be engrossed, and on further motion by the same senator the Senate concurred with the House in the indefinite postponement of House Amendment A.

On further motion by the same senator, House Amendment B was adopted, and the bill as amended by House Amendment B was passed to be engrossed.

Mr. DEARTH of Fenobscot: Mr. President, I move to take from the table S. D. 242, An Act to amend Section 1 of Chapter 69 of the Revised Statutes. relating to the assessment and collection of inheritance tax.

The motion was agreed to, and the same senator then presented the following amendment and moved its adop. tion.

Senate Imendment A to S. D. 242

Amend by striking out the last sentence in said bill beginning with the word "all" in the 53rd line of said bill.

The motion was agreed to, Senate Amendment A was adopted, and the bill was committed to the committee on second reading.

Mr. DAVIES of Cumberland: Mr. President, I move to take from the table S. D. 220, An Act to regulate the practice of the system, method or science of healing known as Osteopathy, creating a board of examination and registration for those desiring to practice the some, and providing penalties for violation of this act.

The motion was agreed to, and then the senator from Cumberland, Senator Davies, yielded to the senator from York, Senator Gordon.

Mr. GORDON: Mr. President. I move this bill be recommitted to the committee on judiciary, in concurrence with the House.

Mr. DAVIES: Mr. President, I only desire to be recorded as voting against the recommitment of this bill to the judiciary committee.

A viva voce vote being taken, the bill was recommitted to the committee on judiciary.

Mr. EMERSON of Aroostook: Mr. President I move to take from the table S. D. 233, An Act to establish a State reformatory for men.

The motion was agreed to, and upon further motion by the same senator the report of the committee, ought to pass, was accepted, the bill was given its second reading, and passed to be engrossed.

On motion by Mr. Lord of York, H. D. 347, An Act to provide for the removal of electric wires and poles when necessary for the repair of streets or removal of buildings, was taken from the table.

On further motion by the same senator, House Amendment A was adopted in concurrence.

The same Senator then offered Senate Amendment A and moved its adoption.

Senate Amendment A to H. D. 347 Amend H. D. 347 by adding at the end thereof the following words:

Provided however, that unless the utility and the person or corporation desiring to cut, disconnect or remove any wires or poles, owned or used under contract by such utility for transmitting train orders or opening block signals, first agree upon the terms thereof, no such wires, pole or poles, shall be cut, disconnected, or removed, until after, and in accordance with, a permit therefor granted by the public utilities commission, and actual notice to the utility owning or using such wires or poles, and hearing. At such hearing said commission may grant such permit on such terms and conditions, and make such apportionment of the expense arising thereunder as they deem best. Whoever violates the provisions of this clause shall be punished in the manner above provided for violations of other portions of this section.

The motion was agreed to, Senate Amendment A was adopted, and the bill was passed to be engrossed as amended, and sent down for concurrence.

The rules were suspended, and the senator from York, Senator Deering, introduced a resolve in favor of the clerk of the committee on towns and moved its reference to the committee on appropriations and financial affairs.

The motion was agreed to and the bill was so referred.

The rules were suspended, and the senator from York, Senator Deering introduced a resolve in favor of Forrest E. Cross, for services as clerk, stenographer and messenger to the committee on towns, and moved its reference to the committee on appropriations and financial affairs.

The motion was agreed to and the bill was so referred.

On motion by Mr. Gannett of Kennebec, the rules were suspended and that Senator introduced the following report out of order:

The committee on executive mansion to which was recommitted the resolve entitled "Resolve authorizing and empowering the Governor and Council to acquire by purchase the residence of the late James G. Blaine, and such other property contiguous or adjacent thereto, to be used in connection therewith. as said Governor and Council may determine, for an executive mansion,' have had the same under consideration and ask leave to report the accompanying resolve in new draft entitled "Resolve authorizing and instructing the Governor and Council to make such alterations and improvements of the residence of the late James G. Blaine, recently given to the State by Mrs. Harriet Blaine Beale, as may be necessary, and to furnish it suitably, to serve the purpose of an executive mansion, and to acquire by purchase such contiguous property as may be needed for said purpose.

The report was accepted and the resolve tabled for printing under the joint rules.

Mr. DAVIES of Cumberland: Mr. President, I rise for the purpose of making an inquiry about S. D. 185, An Act to amend Section 16, Chapter 9 of the Revised Statutes, to provide for inventory of exempt live stock, etc. My impression is that an amendment was offered to that bill and the motion to lay on the table was to carry the bill and the amendment. I have an amendment which I desire to offer and I do not seem to discover it here this morning.

The PRESIDENT: The Chair will state to the senator from Cumberland, Senator Davies, that this bill was recalled from the committee on engrossed bills for the purpose of offering an amendment, and the amendment does not appear to have been offered up to the present time.

Mr. DAVIES: Thank you.

Mr. PEACOCK of Washington: Mr. President, I move we take from the table S. D. 125, with veto message of the Governor, on An Act to authorize the construction of a weir in the tide waters of Roque Harbor in the town of Jonesport.

The motion was agreed to, and the same senator further moved that the Senate sustain the Governor's veto.

The PRESIDENT: The pending question is whether this bill shall become a law notwithstanding the ob-

jection of the Governor. It is necessary to have a roll call, and a twothirds-vote is necessary to pass over the veto.

Those voting yes vote to pass

bill over the veto of the Governor; those voting no vote to sustain the veto.

The secretary called the roll. No senators voted "yes". Those voting "no" were Messrs. Ames, Babb, Baxter, Butler, Chick, Clement, Cobb, Creighton, Davies, Dearth, Deering, Emerson, Folsom, Gannett, Googin, Grant, Gurney Higgins, Holt, Lewis, Lord. Metcalf, Parent, Peacock, Ricker, Thombs, Thornton, Tuttle, Walker--29. Absentees, Messrs. Gordon and Stanley--2.

Twenty-nine senators having voted no, the veto message of the Governor was sustained, and the bill failed to pass.

On motion by Mr. Chick of Kennebec,

Adjourned until tomorrow morning at 10 o'clock.
