Friday, Jan. 21, 1921.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Young of Hallowell.

Journal of previous session read and approved.

Papers from the Senate disposed of in concurrence.

The following bills, resolves and petitions were received and, upon recommendation of the committee on reference of bills, were referred to the following committees.

Appropriations and Financial Affairs

By Mr. Forbes of Paris: Resolve in favor of Benjamin A. Swasey.

By Mr. Conant of Buckfield: Resolve to reimburse the town of Dixfield for money paid for sheep killed by bears.

Ways and Bridges

By Mr. Hinckley of South Portland: Bill "An Act providing that all state and state-aid roads and highways shall be constructed only of stone and gravel." (500 copies ordered printed.)

By Mr. Belmore of Princeton: Resolve in favor of the town of Princeton to aid in road construction.

By Mr. Roberts of Lyman: Resolve in favor of the town of Lyman to aid in road construction. By Mr. Atherton of Stacyville Pl.: Resolve to reimburse the town of Mattawamkeag for planking Logan bridge, so-called, in Mattawamkeag.

By Mr. Belmore of Princeton: Resolve to aid in repairing the "Vanceboro Road," so-called, through Township No. 1, Range 2, and No. 1, Range 3, in Washington County.

By the same gentleman: Resolve in favor of road in Danforth.

By Mr. Owen of Milo: Resolve appropriating money to aid in repairing a highway in the town of Milo, in the county of Piscataquis, with statement of facts.

By Mr. Eastman of Fryeburg: Resolve to aid the town of Hiram in constructing a road.

By the same gentleman: Petition of the selectmen of the town of Newry, in Oxford county, and 83 others, in favor of the same.

On motion by Mr. Maxwell of East Livermore, the rules were suspended and the following order was introduced out of order:

Ordered, that the bill relating to the 48-hour law, which was referred to the joint committee of Labor and Legal Affairs be returned to the House, and further that it be tabled for printing, and 1000 copies thereof be printed for the use of the House.

The order received a passage.

Orders

On motion by Mr. Moody of York, it was

Ordered, that the House employ a special messenger to the Speaker who shall serve for the present session only, and receive a salary not to exceed that of the Assistant Messenger of the House.

First Reading of Printed Bills and Resolves

House 18. An act to amend Chapter 171 of the Private and Special Laws of 1879, entitled 'an act amendatory to an amended act incorporating the Kennebec Log Driving Company', approved March 5, 1869, as amended by Chapter 14 of the Private and Special Laws of 1917.

House 19. An act to authorize the sale of property and assets of the Moose River Log Driving Company and to provide for the dissolution of said corporation.

House 20. An act to amend the charter of the Kennebee Log Driving Company, as amended by Chapter 402 of the Private and Special Laws of 1885, and by Chapter 13 of the Private and Special Laws of 1917.

Orders of the Day

The SPEAKER: The Chair presents an act to amend Chapter 50 of the Revised Statutes, as amended by Section 9 of Chapter 238 of the Public Laws, of 1919, relating to Workmen's Compensation, recalled from the committee on Judiciary on motion by the gentleman from Stonington (Mr. Clarke) and recognizes that gentleman.

Mr. CLARKE of Stonington: Would it be well, Mr. Speaker, to dispose of the matter this morning rather than Wednesday morning?

The SPEAKER: The printing was to be ordered?

Mr. CLARKE: No, simply referred to a joint committee.

The SPEAKER: If there is no objection on the part of the House a motion would certainly carry.

On motion by Mr. Clarke of Stonington the vote was reconsidered whereby the bill was referred to the committee on Judiciary; and on further motion by the same gentleman the bill was referred to a joint committee consisting of the committees on Judiciary and Labor, and the bill was sent to the Senate for concurrence.

On motion of Mr. Case of Lubec, the rules were suspended, and the following resolution was introduced out of order:

Joint Resolution

Whereas, all Federal Aid for highway improvement provided by acts of Congress approved July 11, 1916 and February 28, 1919 has been apportioned to the states in accordance with the terms of said acts; and

Whereas, there is now pending in Congress a bill introduced by Representative McArthur providing for a continuance of Federal Aid in the amount of one hundred million dollars per year for each of the four fiscal years beginning July 1, 1921:

Now therefore, be it resolved that it is the sense of the Legislature of Maine that said McArthur bill should have a prompt passage by Congress, and we hereby request our Senators and Representatives to work for a vote for the passage of said bill.

And be it further resolved, that the Secretary of State be instructed to furnish forthwith to each of the Maine Senators and Representatives in Congress a certified copy of this resolution.

The resolution received a passage, and was sent to the Senate for concurrence.

On motion by Mr. Daigle of Mada-waska,

Adjourned until 4.30 P. M. Tuesday, January 25, 1921.
