Monday, Feb. 28, 1921.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Layton of Augusta.

Journal of previous session read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: Bill An Act granting to county commissioners authority to regulate clerk hire in county offices, which was referred to the committee on Legal Affairs in the House, February 24.

Comes from the Senate referred to the committee on Salaries and Fees in non-concurrence.

In the House, on motion by Mr. Buzzell of Belfast that body voted to recede from its former action, and concur with the Senate in referring the bill to the committee on Salaries and Fees.

From the Senate: Bill An Act in relation to clerk hire in county offices, which was referred to the committee on Legal Affairs in the House, February 24.

Comes from the Senate referred to the committee on Salaries and Fees in non-concurrence.

In the House, on motion by Mr. Buzzell of Belfast, that body voted to recede from its former action and concur with the Senate in referring the bill to the committee on Salaries and Fees.

From the Senate: Joint order relative to reorganization and consolidation of State departments, which was read and passed in the House February 8.

Comes from the Senate indefinitely postponed in non-concurrence.

In the House, on motion by Mr. Buzzell of Belfast, that body voted to recede from its former action and indefinitely postpone the order in concurrence with the Senate. From the Senate: Joint order relative to codification and grouping of the various enactments creating and governing the State administrative and executive departments, which was read and passed in the House, February 17th, as amended by House Amendments A and B.

Comes from the Senate indefinitely postponed in non-concurrence.

In the House, on motion by Mr. Buzzell of Belfast, that body voted to recede from its former action and indefinitely postpone the order in concurrence with the Senate.

The following bills, resolves and petitions were received and, upon recommendation of the committee on reference of bills, were referred to the following committees.

By Mr. Smith of Skowhegan: Petition of Elizabeth A. Marble and 22 others of Skowhegan in favor of bill relating to Maine Medical School.

Judiciary

By Mr. Moody of York: Petition of Walter H. Junkins and 57 others of York, in favor of an Act to restrict the size of bill boards and signs.

By Mr. Holley of No. Anson: Bill An Act authorizing towns to elect certain municipal officers by secret ballot. (1000 copies ordered printed.)

By Mr. Holley of No. Anson: Bill An Act to establish the fiscal year of the State.

By Mr. Wight of Newry: Bill An Act to amend Chapter 4, Section 13 of the Revised Statutes, relating to longer terms of office for selectmen and assessors. (500 copies ordered printed.)

By Mr. Clarke of Stonington: Petition of George W. Silver and 35 others of Stonington in favor of passage of the "Workmen's Compensation Law."

By the same gentleman: Petition of Archie E. Barbour and 56 others of Stonington in favor of same.

By Mr. Holley of No. Anson: Resolve for extra pay to the Maine Volunteers War with Spain.

Public Utilities

By Mr. Wadsworth of Winthrop: Bill "An Act to consolidate the Steamboat Inspection Department with the Public Utilities Commission and revise the provisions of Sections 4 to 16, inclusive, of Chapter 59 of the Revised Statutes, relating to the provisions for safety on inland steamers." (500 copies ordered printed.)

By Mr. Wadsworth of Winthrop: Bill "An Act to amend Chapter 117, Section 17 of the Revised Statutes relating to the salary of the State Auditor."

By Mr. Weeks of Dresden: Bill An Act to increase the salary of the county commissioners in Lincoln County.

By Mr. Baker of Steuben: Remonstrance of Frank C. Nash and 35 others of Cherryfield against the proposed nine inch Lobster Law.

By Mr. Clarke of Stonington: Remonstrance of Alma Eaton and 58 others of Little Deer Isle against same.

By the same gentleman: Remonstrance of Clarence L. Smith and 29 others of Swan's Island against same.

Ordered, that the use of the hall of the House of Representatives be granted for a conference of Federal and State enforcement officers, with an address by Hon. Wayne B. Wheeler of Washington, District of Columbia, on the afternoon of March 10, 1921, at 4.30 o'clock.

Reports of Committees

Mr. Mason from the Committee on Legal Affairs reported "Ought not to pass" on Bill "An Act to prohibit all persons from entering on or traveling on cultivated blueberry lands in Washington County."

Same gentleman from same Committee on Bill "An Act to regulate the use of motor vehicles with solid tires" reported that the same be referred to Committees on Judiciary and Ways and Bridges jointly.

Mr. Gardiner from the Committee on Military Affairs on Bill "An Act to provide for the acceptance of the benefits of An Act by the Senate and House of Representatives of Congress assembled entitled 'An Act to provide for the promotion of vocational rehabilitation of persons disabled in industry and otherwise and their return to civil employment' and to provide for the administration of the same" reported that the same be referred to the Committee on Education. Mr. Rounds from the Portland Delegation reported "Ought not to pass" on Bill "An Act to co-ordinate the duties of the Board of Health and Board of Overseers of the Poor and Workhouse in the city of Portland."

Reports read and accepted.

On motion by Mr. Holley of North Anson, tabled pending acceptance of report.

Mr. Newcomb from the Committee on Claims reported "Ought to pass" on Resolve in favor of Helen Vaun Bangs.

Mr. Smith from the same Committee reported the same on Resolve to reimburse the town of Mapleton.

Mr. Crafts from the committee on

Inland Fisheries and Game reported the same on Bill "An Act to amend Section 55 of Chapter 33 of the Revised Statutes as amended by Chapter 219 and Chapter 244 of the Public Laws of 1917 and by Chapter 62 of the Public Laws of 1919 relating to the protection of game birds."

Mr. Barney from the same committee reported same on Bill "An Act to protect the water supply of the town of East Livermore."

Mr. Landers from same committee on Bill "An Act to amend Section 1 of Chapter 66 of the Public Laws of 1917 as amended by Chapter 244 of the Public Laws of 1917 relating to non-resident fishing license fees" reported the same in a new draft under same title and that it "ought to pass."

Mr. Gardiner from the committee on Judiciary reported "ought to pass" on Bill "An Act to authorize the town of Rangeley to acquire wharves in Rangeley Lakes of the Rangeley Lakes Steamboat Company."

Mr. Murray from the committee on Legal Affairs reported the same on Bill "An Act authorizing the town of Cape Elizabeth to adopt a corporate seal."

Mr. Fagan from the same committee reported the same on Bill "An Act to incorporate the Monmouth Water and Sewer District."

Mr. Mason from the same committee on Bill "An Act to confirm and make valid the municipal election held in the city of Eastport on the first Monday of March 1920" reported same in a new draft under same title and that it "ought to pass."

Reports were read and accepted, and the bills and resolves were ordered printed under the joint rules.

Mr. Emery from the committee on Towns reported "ought to pass" on Bill "An Act to amend Section 2 of Chapter 574 of the Private and Special Laws of 1856 entitled 'An Act to incorporate the Kendall's Mills Village Corporation' as amended by Chapter 139 of the Private and Special Laws of 1891."
