Paper from the Senate out of order. Ordered, the House concurring, that a special committee of five members, two from the Senate and three from the House of Representatives, be appointed to act in conjunction with a committee of two from the Governor's Council, to be appointed by the Governor, for the purpose of investigating the proposed location of a bridge over the Kennebec River in the vicinity of Bath and Woolwich, said committee to make such investigation at the earliest possible time and to report forthwith to the Legislature.

In the Senate read and passed. In the House passed in concurrence.

RECESS Orders of the Day

On motion by Mr. Flint of Monson it was voted to take from the table the order relative to the use of the hall tomorrow afternoon, tabled by that gentleman before recess; and on further motion by the same gentleman the order was indefinitely postponed.

Further papers from the Senate, out of order, disposed of in concurrence.

The SPEAKER: Under orders of the day the Chair will appoint the members on the part of the House on the committee with reference to the Bath bridge, Messrs.
