SENATE

Tuesday, January 25, 1927.

Senate called to order by the President.

Prayer by the Rev. H. A. Clark of Gardiner.

Journal of previous session read and approved.

From the House: The following order:

Ordered, the House concurring, that Major General Mark L. Hersey, executive director of State of Maine Associates active retired on half-pay, now stationed at Washington, D. C., be directed to appear before the State of Maine tegislative publicity committee, on February 15th, or sooner if called, for a public hearing and conference on State of Maine publicity matters,

In the Senate, read and passed on January 18th.

In the House, indefinitely postponed in non-concurrence.

Mr. SPEAR of Cumberland: Mr. President, I will move that the Senate recede and concur with the House. Apparently the purpose of the order has been accomplished. I will read from the legislative record of the House of January 20th where Mr. Eustis of Strong stated that he had in his hands at that time a wire from Major General Hersey and which reads as follows:

"I have in my hand a telegram from General Hersey, dated January 20th, which I will read: 'Governor of Maine, State House, Augusta, Maine. Shall be pleased to appear before the publicity committee of Maine Legislature at any time it may desire during next month on reasonable notice, subject only to prior engagements. (Signed) Mark L, Hersey.'"

The motion to recede and concur prevailed.

From the House: The following order:

Ordered, the Senate concurring, that the President of the Senate and the Speaker of the House of Representatives of the 83rd Legislature send letters of sympathy to the family of the late Senator Bert M. Fernald.
