The President laid before the Senate the veto ressage from Governor Brewster on "Resolve, Appropriating Money to Pay Claims Allowed by the Committee on Claims."

Mr. SMITH of Somerset: Mr. President, I have prepared, and hope later on in the session to reintroduce, twenty-eight of the resolves contained in this veto. I can see no reason for further objection to the same and hope that the Governor's veto may be at this time sustained.

The PRESIDENT: The question is, shall this resolve become a law not withstanding the objection of the Governor? Those who wish the resolve to become a law notwithstanding the objection of the Governor will answer "Yes" when their names are called. Those who wish to sustain the veto of the Governor will answer "No" when their names are called. Is the question plain? The Secretary will call the roll.

The roll was called and all Senators being present and voting nay, the veto of the Governor was sustained.

Mr. SMITH of Somerset: Mr. President, out of order, I move for a suspension of the rules for the purpose of introducing various resolves without a committee reference. The reason therefor is that these resolves have already been acted upon favorably by a previous committee. The 82nd Legislature also passed the same. It would therefore seem unnecessary to make further expense to the state or more trouble to the committee or to cause parties interested in these resolves to come here again. I therefore move that the rules be suspended and that I be allowed to introduce

The PRESIDENT: The will state that in as much as these resolves are introduced severally and not under blanket that it is the opinion of the Chair that they will go on separately. The Chair would ask the Senator from Somerset, Sepator Smith, if that is not the intention.

Mr. SMITH: I would say Yes, Mr. President.

Thereupon, on further motion by the Senator from Somerset, Senator Smith, these several resolves were passed to be engrossed.

Mr. PERKINS of Pencbscot: Mr. President, I move to take from the table at this time House Paper 34, an act relating to the salaries of the Judge and Recorder of the Bangor Municipal Court, tabled by me January 20th, pending reference to a committee.

The motion prevailed, and, on further motion by the same Senator, the act was referred to the committe on salaries and fees in non-concurrence.

Mr. GRANVILLE of York: Mr. President, I move to take from the table at this time House Paper 44, an act relating to appropriation of motor vehicle registration and operators' license fees, tabled by me yesterday pending reference to a committee.

The motion prevailed.

Mr. GRANVILLE: 1 now move you that this act be referred to the committee on ways and bridges in non-concurrence and would say in support of that motion that this and five other bills tabled by me yesterday coming up from the House have to do with the moneys of the Highway Department. Those moneys are appropriated and apportioned in the Legislature by the Ways and Bridges. Committee on They have, in the handling of the matters which come before them, the expenditure of practically fifty per cent of the money which is expended in the state. They have this year an extensive and important program prepared to present to this Legislature and it is my opinion that, to avoid undue delay and that the matter be properly considered, should all come before one committee. If the Committee on Ways and Bridges has to wait for the action of another committee for them to report and this Legislature to act upon their report before they can proceed with their program, I am afraid it will be very late in the session and I therefore move you that my motion have passage.

The motion prevailed.

Mr. GRANVILLE: I now move, Mr. President, that House Paper 45, an act relating to appropriation of automobile fees, tabled by me on January 25th pending reference to a committee be taken from the table.

The motion prevailed and on further motion by the same Senator the bill was referred to the Committee on Ways and Bridges in nonconcurrence.

Mr. GRANVILLE: Mr. President, I now move that House Paper 46, an act relating to maintenance of the State Highway Police, tabled by me on January 25th, pending reference to a committee, be taken from the table.

The motion prevailed and on further motion by the same Senator the bill was referred to the Committee on Ways and Bridges in non-concurrence.

Mr. GRANVILLE: Mr. President, I now move that House Document 12, resolve to appropriate money for the maintenance of the motor vehicle department of the office of the Secretary of State, tabled by me on January 25th, pending reference to a committee to be taken from the table.

The motion prevailed and on further motion by the same Senator the resolve was referred to the Committee on Ways and Bridges in non-concurrence.

Mr. GRANVILLE: Mr. President, I now move that House Document 13, resolve to appropriate money for the state highway department, tabled by me on January 25th, pending reference to a committee, be taken from the table.

The motion prevailed and on further motion by the same Senator the resolve was referred to the Committee on Ways and Bridges in non-concurrence.

Mr. GRANVILLE: Mr. President, I now move that House Document 14, resolve to appropriate money for the maintenance of State Highway Police, tabled by me on January 25th, pending reference to a commitee, be taken from the table.

The motion prevailed and on further motion by the same Senator the resolve was referred to the Committee on Ways and Bridges in non-concurrence.

Mr. SPEIRS of Cumberland: Mr. President, I move to take from the table House Document 17, an act to

revise the schedule of fees for registration of motor vehicles, tabled by me January 25th, pending reference to a committee.

The motion prevailed and on further motion by the same Senator the bill was referred to the Com-

mittee on Ways and Bridges in non-concurrence.
