SENATE

Wednesday, February 16, 1927 Senate called to order by the President.

Prayer by the Rev. A. T. McWhorter of Augusta.

Journal of previous session read and approved.

On motion by Mr. Roberts of York, out of order and under suspension of rules, it was

Ordered, that the President of the Senate, in behalf of this body, send a message of sympathy to the family of Honorable James G. C. Smith, late member of the House of Representatives from the city of Biddeford. Mr. ROBERTS: Mr. President, as

Mr. ROBERTS: Mr. President, as a further mark of respect to Mr. Smith, I move you that this body rise and stand for one minute with bowed heads.

The motion prevailed and the members of the Senate rose and stood with bowed heads.

Message from the House

A message was received from the House conveyed by the Clerk, proposing a Joint Convention of both branches of the Legislature to be held in the Hall of the House this evening at eight o'clock for the purpose of listening to an address by the Honorable Gifford Pinchot and for the further purpose of inviting the Governor to introduce to the convention the speaker of the evening.

The PRESIDENT: The Senate hears the message. Is it the pleasure of the Senate to concur in the proposition of the House for a Joint Convention?

The Senate so voted and the Secretary was thereupon charged by the President with a message to the House informing that body that the Senate concurred in the proposition of the House for a Joint Convention.

Subsequently the Secretary reported that he had delivered the message with which he was charged.

Papers from the House disposed of in concurrence.

From the House: An Act to amend Section 1 of Chapter 97 of the Revised Statutes relative to right to erect and maintain mill dams and to divert water by a canal for mills. (S. D. 62)

From the House: Resolve authorizing the Governor and Council to sell certain State land situate in Bangor in the County of Penobscot. (H. P. 615)

In the Senate, referred in concurrence.
