Thursday, February 17, 1927. Senate called to order by the President.

## Communications from the Auditor's Office

STATE OF MAINE DEPARTMENT OF STATE AUDITOR

Augusta, February 15, 1927.
To the Honorable Senate and House of Representatives:

I refer to you herewith certain deficiencies, amounting in total to \$20,-409.68. These are referred to you under Section 84, of Chapter 2, Revised Statutes which reads in part "\* \* \* \* whenever any appropriation or fund is expended all bills and accounts presented to the State Auditor and drawn on said expended appropriation shall not be approved by him, but shall be reported by him to the next session of the Legislature."

In recent years, since the establishment of the State Contingent Fund, the deficiencies so refererred to have been smaller in amount than formerly for the reason that most of such deficiencies were paid from said State Contingent Fund. The law authorizes the Governor and Council, where the appropriation is insufficient, "to pay outstanding bills or accounts that were properly chargeable to the several appropriations for the previous fiscal

year ending the thirtieth day of June preceding the time of payment." (Section 3. Chapter 164, Public Laws 1925.) Therefore no claims incurred after June 30, 1925, have been included except \$139.43 for the Commissioner of Education. Inasmuch as lapsed balances of that Department accrue to the school fund and not to the State Contingent Fund. I suggest that in acting upon these, authority to pay, if granted, should require this amount, as well as all other amounts on account of that department, to be deducted from the permanent school fund.

One claim in favor of Ralph Rush, of Benedicta, \$72.00, is for sheep destroyed by bears while being pastured in Township 2, Range 6, Penobscot County. As the law provides that the municipal officers of the town where the animals are destroyed shall make ciaim for same, and as this is an unorganized place, I had no authority to pay the same.

The bills and correspondence relative to these matters are on file in the office of the State Auditor and will be furnished to the Committee on application.

#### Orders

Mr. Smith of Somerset presented the following order:

ORDERED, the House concurring, that a Committee composed of two Senators appointed by the President of the Senate, three members of the House of Representatives appointed by the Speaker of the House, representing employees and employers subject to the Workmen's Compensation Act and the insurance carriers doing business in the State of Mains. is hereby authorized and directed to make a full investigation of all evidence and phases of the operation, during the last ten years, of the Workmen's Compensation Law of this State, and all elements and phases of the cost of Workmen's Compensation Insurance in State; and make full report in writing to the Governor on or before October 1, 1928.

Such Committee is hereby given full power to summons witnesses and require the production of papers and documents and records, such witnesses to receive the same attendance fees as obtains in the Supreme Judicial Court.

Such Committee is to serve without pay other than actual expenses and is authorized to employ at the expense of the State all necessary expert or other assistance.

To enable such Committee to perform its duties the Governor and Council are authorized to pay the expenses of this investigation and report, out of any moneys available to the Governor and Council therefor.

Mr. SMITH: I would like to offer at this time a few words of explanation concerning the order.

Fellow members, I wish to state that it has been my privilege to serve many years in the legislature and that during this service of humble activity I have never before introduced an order of investigation. In fact, I do not believe as a rule that this kind of legislation is satisfactory and I would not at this time ask an order, an order thus presented, if it were possible to obtain complete information on this subject in any other way.

Many times I have asked various legislatures to liberalize the Workmen's compensation; have been successful in obtaining various amendments but each request has always been opposed by insurance carriers, these organizations pretending that any effort to raise or liberalize the workmen's compensation would mean higher rates. We are advised that there are many corporations in the State of Maine who insure their employees and give them more liberal compensation than it is possible to obtain under our laws and that these companies effect a very great saving as compared ith the prices charged by insurance companies.

We are also informed that the State of Ohio under state insurance returns to employees injuried in industry ninety-five cents out of every dollar paid in premiums while according to our understanding of the reports of our insurance commissioner only about sixty-seven cents out of each dollar thus paid is returned to the man or woman injured in industry.

It is difficult for a layman to discuss with insurance companies the figures and facts and conditions leading up to the charges. It is necessary in order to have a complete investigation to have expert consideration, an unbiased actuary to consider this matter and I am pleased to state that both the Federation of Labor and the Industrial Accident Association of Maine are asking for the passage of this order.

We believe that it is time that men and women who give their limbs and lives to industry understand whether they are obtaining a fair deal. We believe it is time for industries, for the employer who seeks to protect his employees to learn whether they are obtaining a square deal. We believe it is time for the consumer, who in the end pays the price of this insurance, to know whether the millions of dollars thus invested are expended prudently.

Mr. President, I wish to state that in no wise does this order seek to bring about state insurance, nor is it intended to wrongfully injure a single individual but we hope as a result of this investigation that our companies may be vindicated for the charges they are making. I trust that this order may have a passage, and so move
