I will say in support of the motion for reconsideration that this resolve has solely to do with the teachers' pension and is granted it would be paid out of the funds of the educational department and I think the proper reference would be to the Committee on Education.

The motion prevailed and upon further motion by the same Senator the resolve was referred to the Committee on Education in non-concurrence.
