SENATE

Friday, March 4, 1927

Senate called to order by the President.

Prayer by the Rev. Carl N. Garland of Augusta.

Journal of previous session read and approved.

On motion by Mr. Carter of Androscoggin, out of order and under suspension of the rules, it was

Ordered, the House concurring, that when the Senate and House adjourn they adjourn to meet Tuesday afternoon, March 8th, at four-thirty o'clock,

Sent down for concurence.

Subsequently the foregoing order came back from the House read and passed in concurrence.

Papers from the House disposed of in concurrence.

From the House: An Act granting to Charles H. Scott the right to maintain a ferry across Eggemoggin Reach in Hancock County. (H. D. 147).

(In Senate, February 23, passed to be engrossed in concurrence).

In the House, that body having reconsidered its action whereby the bill was passed to be engrossed, having adopted House amendment A, and having passed the bill to be engrossed as amended by House Amendment A in non-concurrence.

In the Senate:

The PRESIDENT: Does any Senator care to hear House Amendment A read?

Mr. GRANVILLE of York: I would like to hear it read, Mr. President.

(The Secretary read House Amendment A).

Thereupon, the Senate reconsidered its former action whereby this bill was passed to be engrossed, House Amendment A was adopted in concurrence and the bill as so amended was passed to be engrossed in concurrence,

From the House: The Majority of the Committee on Judiciary, on An Act relating to advertising signs along public ways, (S. D. 11) reported that the same ought to pass.

In the House, the bill indefinitely postponed.

Mr. OAKES of Cumberland: Mr. President, I move that this matter lie upon the table pending consideration.

The motion to table prevailed. Mr. CARTER of Androscoggin: Mr. President, I would like to ask through the Chair if the Senator from Cumberland, Senator Oakes will designate a time certain for the disposition of the matter which has just been tabled by him.

The PRESIDENT: The Senator from Cumberland, Senator Oakes may reply if he wishes to.

Mr. OAKES: Mr. President, I will assign next Wednesday morning at ten o'clock.

The Senate so voted

From the House: The Committee on Mercantile Affairs and Insurance, on An Act relating to insurance upon lives of directors, officers, agents and employes of corporations and prescribing what shall constitute evidence of due authority for all corporate actions with reference thereto (H. D. 7) reported the same in a new draft, under the same title (H. D. 287) and that it ought to pass.

In the House, the report was accepted, and the new draft subsequently indefinitely postponed.

In the Senate:

Mr. WOODS of Penobsco' Mr. President, I move that this bill lie upon the table.

Mr. CARTER of Androscoggin: Mr. President, may I ask the Senator, (Mr. Woods of Penobscot) through the Chair to assign a day certain?

Mr. WOODS: I will assign next Wednesday morning, Mr. President.

The motion to table and assign prevailed.

From the House: The Committee

on Taxation, on An Act relating to the excise tax on railroads (H. D. 23) reported that the same ought to pass.

In the House, passed to be engrossed as amended by House Amendment A.

On motion by Mr. Harriman of Kennebec, tabled pending consideration and next Wednesday assigned.

Mr. ROBERTS of York: Mr. Presidet, will you please have read the report of the Committee on the Act relating to enlarging a public cemetery or burying ground (H. D. 90)?

(The Secretary read the report of the Committee on Judiciary, the report being "ought not to pass.")

From the House: The Committee on Legal Affairs, on an act relative to passes on Common Carriers for Public Utilities Commission (H. D. 168), reported that the same ought to pass.

In the House, the report was read and accepted.

Report read and accepted in concurrence.

In the Senate:

Mr. CARTER of Androscoggin: Mr. President, I move that this bill be tabled pending acceptance of the report.

The PRESIDENT: The Chair has declared the report accepted. Does the Senator wish to move to reconsider the vote?

Mr. CARTER: Yes, Mr. President, I would move to reconsider. I had thought that I had spoken before the gavel fell.

The motion to reconsider prevailed and on further motion by the same senator the bill was tabled pending acceptance of the report.

Mr. BUZZELL of Oxford: Mr. President, would it be in order at this time to move reconsideration of an action this morning or would it be better to wait until Orders of the Day?

The PRESIDENT: It will make it easier for those who keep the records if the Scnator (Mr. Buzzell of Oxford) will hold it until Orders of the Day?

From the House: The Committee on Library, on Resolve for the purchase of 125 copies of the History of the Town of Dresden (H. D. 179) reported that the same ought to pass. In the House, reported read and accented.

In the Senate, the report was accepted in concurrence and on motion by Mr. Foster the resolve was tabled pending first reading.

P. 406); against passage of act abolishing the Commission of Sea and Shore Fisheries. Sent down for concurrence.

Reports of Committees

Mr. Dwinal, from the Committee on Legal Affairs, on bill An Act to repeal acts incorporating Fort Kent Village Corporation. (S. D. 29.) reported that legislation is inexpedient.

Mr. Morrison, from the same Committee, on bill An Act relating to the appointment of public administrators. (S. D. 63.) reported that the same ought not to pass.

The Committee of Conference, on disagreeing action of the branches of the Legislature, on but An Act to amend Section 1 of Chapter 97 of the Revised Statutes relative to right to erect and maintain mill dams and to divert water by a canal for mills. (S. D. 62) reported a recommendation that the same be referred to the Committees on Public Utilities, Judiciary and Interior Waters, jointly.

The report was read and accepted and sent down for concurrence.

Mr. Lord, from the Committee on Agriculture, on bill An Act to assent to the purpose and provisions of An Act of the Congress of the United States entitled "An Act to authorize the more complete endowment of agricultural experiment stations, and for other purposes" (S. P. 234) reported that the same ought to pass.

Mr. Foster, from the Committee on Appropriations and Financial Affairs, on Resolve to reimburse Recess Committee for expenses (S. P. 328) reported that the same ought to pass.

Which reports were severally read and accepted and the bill and resolve ordered printed under the joint rules.

Mr. Holmes, from the Committee on Legal Affairs, on bill "An Act to amend Section 27 of Chapter 84 of the Revised Statutes of Maine relating to Applicants for admission to the Bar of this State" (S. P. 152) (S. D. 65) reported that the same ought to pass.

The bill was read once, and Tuesday, March 8th, assigned for second

reading.

The Report was read and ordered placed on file.

Further papers from the House disposed of in concurrence.

On motion by Mr. Buzzell of Oxford, the Senate reconsidered its former action whereby An Act to Regulate the manufacture, distribution, sale and commercial use of cosmetics (H D. 309), was referred to the Committee on Agriculture, and on further motion by the same senator the bill was tabled pending reference.

On motion by Mr. Woods of Penobscot, the Senate reconsidered its former action whereby An Act to consolidate the general superintendent's management and control of the State Prison, the Reformatory for Men and Reformatory for Women under one board of trustees (S. P. 388) was referred to the Committee on Judiciary, and on further motion by the

same senator the bill was referred to the Committee on State Prison.

On Motion by Mr. Granville of York, the Senate voted to take from the table An Act to provide an excise tax upon tobacco products (H. D. 274), tabled by that senator on March 3rd pending reference to the committees on Taxation and Education jointly; and on further motion by the same senator the bill was referred to the Committee on Taxation and Education jointly.

On motion by Mr. Case of Washington, the Senate voted to take from the table An Act relative to tax on Gasoline (S. P. 389) tabled by that senator on March 2nd, pending reference.

Mr. CASE: Mr. President, I now yield to the senator from Cumberland, Senator Speirs.

Mr. SPIERS: Mr. President, I ask leave to withdraw this bill which I introduced a few days ago.

Thereupon the Senator from Cumberland, Senator Speirs, was granted leave to withdraw the bill.

Mr. HOLMES: Mr. President, I rise to ask for enlightenment in regard to parliamentary procedure under the rules of the Senate and I will state my question in this form: The Senate has assigned for next Wednesday a number of matters for consideration, now on the table. I should like to know if they will appear on the calendar in the chronological order according to the time when the Senate assigned them; that whether one asigned yesterday will precede one assigned today.

The PRESIDENT: The Chair will state that the asistant secretary makes up the calendar which is sent to the printer and it has been the custom in years past to have the matters which were tabled the day before, for instance, precede those which were tabled today.

Mr. HOLMES: Mr. President, I thank you.

Mr. MAHER: Mr. President, I wish to give notice that I will move, on the next legislative day, reconsideration of the vote whereby an act relative to consolidating the management of various state penal institu-

tions and reformatory institutions was referred to the Committee on State Prison.

The PRESIDENT: The Senate hears the notice of the Senator from Kennebec, Senator Maher. The pa-

pers will be retained within this body.

On motion by Mr. Slocum of Cumberland
