### SENATE

### Thursday, March 10, 1927.

Senate called to order by the President.

Prayer by the Rev. Langdon Quimby of Gardiner.

Journal of previous session read and approved.

Papers from the House disposed of in concurrence.

From the House: An Act relating to the Kennebec Agricultural Society at Readfield. (H. D. 830.)

(In Senate, February 18, referred to the Committee on Agriculture in concurrence.)

In the House, recalled from the Committee by joint order and referred to the Committee on Legal Affairs in non-concurrence.

In the Senate that body receded from its former action whereby the bill was referred to the Committee on Agriculture and the bill was referred to the Committee on Legal Affairs in concurrence.

From the House: An Act relative to the salary of the Mayor of the City of Augusta. (H. D. 889.) (In Senate, February 25, referred

(In Senate, February 25, referred to the Committee on Salaries and Fees in concurrence.)

In the House, recalled from the Committee by joint order, and referred to the Committee on Legal Affairs in non-concurrence.

In the Senate, that body receded from its former action whereby the bill was referred to the Committee on Salaries and Fees and tre bill was referred to the Committee on Legal Affairs in concurrence.

From the House: An Act in relation to the bridge built across the Kennebec River between Bath and Woolwich. (S. P. 315.)

(In Senate, February 23, referred to the Committee on Military Affairs and sent down for concurrence.)

In the House, no action was taken by that/body.

In the Senate:

Mr. DWINAL of Knox: Mr. President, the proponents of the bill now ask leave to withdraw it.

Consent being given the bill was withdrawn.

From the House: An Act to authorize the issuance of bonds for construction of State highways conditioned upon an amendment of the Constitution increasing the amount of bonds issued for State highways and bridges. (S. D. 177.)

(In Senate, March 4, referred to the Committee on Judiciary and sent down for concurrence.)

In the House, referred to the Committee on Ways and Bridges in non-concurrence.

In the Senate: On motion by Mr. Carter of Androscoggin that body receded from its former action and the bill was referred to the Committee on Ways and Bridges in concurrence.

From the House: An Act to provide an excise tax upon tobacco products, and to make the proceeds available for the development of Maine and for general and rural education. (H. D. 274). (In Senate, March 4, referred to

(In Senate, March 4, referred to Committee on Taxation and Education jointly, in non-concurrence.)

In the House, that body voted to insist on its action whereby the bill was referred to the Committee on Taxation.

In the Senate:

Mr. ROBERTS of York: Mr. President, I move that we recede and concur with the House.

Mr. SPEIRS of Cumberland: Mr. President, this bill is to tax cigarettes and tobacco and the returns are to go to education. I think that as the gasoline tax and such matters go to taxation and ways and bridges, this should go to taxation and education and I object to receding and concurring.

The PRESIDENT: Does the Senator care to make a motion?

Mr. SPEIRS: I understand, Mr. President, that there is a motion already before the Senate.

The PRESIDENT: The Senator is correct. There is a motion before the Senate.

Mr. ROBERTS: Mr. President, some time ago when this bill first came to the Senate for reference we had some conversation about referring this to taxation and education and it was so referred by the Senate but it seems at this late date in the session that we are delaying the program and so I think that we ought to recede and concur.

The PRESIDENT: The question is on the motion of the Senator from York, Senator Roberts, that the Senate recede and concur with the House on the reference of this bill to the Committee on Taxation. Is this the pleasure of the Senate?

Mrs. PINKHAM of Aroostook: Mr. President, I ask for a division of the Senate.

A division of the Senate being had eighteen senators having voted in the affirmative and eight in the negative, the motion to recede and concur prevailed.

From the House: An Act relating to the trapping of fur bearing animals. (H. D. 337.)

In the House, referred to the Committee on Inland Fisheries and Game and Agriculture, jointly.

### Orders of the Day

On motion of Mr. Carter of Androscoggin, the Senate voted to take from the table House report, "ought to pass" on An Act relating to passes on common carriers for public utili-ties commission, (H. D. 168) tabled by that Senator on March 4th pending acceptance of report.

Mr. CARTER: Mr. President, by sort of a verbal agreement between two or three senators, this was to come off the table for argument or motion, today. I have had handed me this morning by another Senator, what may be a suggested amendment to this bill. The hill itself, I am not personally interested in. I will therefore move to retable, pending possible adoption of the suggested amendment, and will especially assign for Wednesday next.

The motion to retable and assign prevailed.

The President laid before the Senate An Act to obtain the benefit of credit allowed under Federal Estate Tax (H. D. 58), tabled on March 9th by Mr. Maher of Kennebec pending passage to be enacted and especially assigned for today.

Mr. MAHER: Mr. President, I am having prepared, I will state, an amendment which is in the Attorney General's office but it is not yet ready and so I move that this be tabled until tomorrow morning, when the amendment will be ready. The motion to retable prevailed.

The President laid before the Senate House Report "A" "Ought to Pass''; House Report "B" "Ought Not to Pass," on Concurrent Resolution Memorializing Congress to abolish Federal Estate (Inheritance) tax (H. D. 11), tabled by  $\mathbf{Mr}$ Holmes of Androscoggin on March 9th, pending acceptance of report A, and especially assigned for today.

Thereupon, upon motion of Mr. Holmes of Androscoggin, the report was retabled and especially assigned for tomorrow morning.

The President laid before the Senate An Act to regulate fishing in Bowler Pond in Palermo in the county of Waldo (H. D. 159), tabled by Mr. Bragdon of Aroostook on March 9th, pending passage to be engrossed, and especially assigned for today.

Mr. BRAGDON of Aroostook: Mr. President, I will yield to the Senator from Waldo, Senator Nickerson.

Mr. NICKERSON of Waldo: Mr. President, I will ask that this matter be retabled and especially assigned for Thursday, next.

The PRESIDENT: The Chair will state that the motion is in order but the gentleman will remember that it will automatically come off the table next Wednesday, we having just passed an order to that effect.

Mr. NICKERSON: Mr. President, desire to change my motion asd Т will move that this Act be retabled and assigned for Tuesday, next.

The motion to retable and assign prevailed.

The PRESIDENT: Any Senator may now proceed to take anything from the table under Orders of the Day, the matters specially assigned for today having been taken care of.

Upon motion by Mr. Smith of Somerset, the Senate voted to take from the table Remonstrance of J. Leroy Willard and others against increase in tax on gasoline, (H. P. 959) tabled by that Senator on March 2nd. pending reference; and upon further motion by the same Senator these papers were referred to the Com-mittee on Taxation and Ways and Bridges jointly in non-concurrence.

Upon motion by Mr. Smith of Somerset, the Senate voted to take from the table An Act relating to children between the ages of 15 and 16 who have not completed the sixth grade (S. P. 409) tabled by that Senator on March 8th, pending reference.

Mr. SMITH of Somerset: I now yield to the Senator from Cumberland, Senator Speirs.

Mr. SPEIRS of Cumberland: Т don't know about the matter, Mr. President. I didn't table it. I don't know what the bill is.

(The Secretary read the title of the bill)

Thereupon, upon motion by Mr. Speirs of Cumberland, the bill was referred to the Committee on Education.

Upon motion by Mr. Bragdon of Aroostook
