#### SENATE

#### Tuesday, March 22, 1927.

Senate called to order by the President.

Prayer by the Rev. Milo G. Folsom of Gardiner.

Journal of previous session read and approved.

#### (Emergency Measure)

Resolve for the laying of the county taxes for the year 1927 (H. D. 399).

This resolve, carrying the emergency clause, required the affirmative vote of two-thirds of the membership of the Senate on its final passage.

Twenty-seven Senators having voted in the affirmative and none opposed, the resolve was finally passed.

#### (Emergency Measure)

Resolve for the laying of the county taxes for the year 1928 (H. D. 398).

This resolve, carrying the emergency clause, required the affirmative vote of two-thirds of the membership of the Senate on its final passage.

Twenty-seven Senators having voted in the affirmative and none opposed, the resolve was finally passed.

Papers from the House disposed of in concurrence.

#### Orders of the Day

On motion by Mr. Holmes of Androscoggin, the Senate reconsidered its former action whereby it passed to be engrossed An Act to incorporate Maine Casualty Company (S. D. 123), and on further motion by the same Senator the bill was laid upon the table.

Mr. CARTER of Androscoggin: Mr. President, are we under Orders of the Day?

The PRESIDENT: We are.

Mr. CARTER: Mr. President, I was about to ask the unanimous consent of the Senate to introduce a bill but before asking for it, in support of it, I would like to say there is a bill pending before the Judiciary Committee, the hearing on which I think is Thursday, in relation to municipal courts in the State. In Livermore Falls there is a municipal court and a complimentary bill was intended to be introduced to go along with this general bill. I got this morning by specialdelivery the complimentary bill, which for some reason had been overlooked in the office of the attorney and this should go along with the bill which we are to hear next Thursday and I now ask the consent of the Senate to introduce this bill.

Consent being given, Mr. Carter of Androscoggin introduced An act to amend Chapter 120 of the Private and Special Laws of 1899 establishing the Livermore Falls Municipal Court as amended by Chapter 34 of the Private and Special Laws of 1919 (S. P. 526), and on further motion by the same Senator the bill was referred to the Committee on Judiciary.

Mr. CARTER: Mr. President, will this bill be transmitted at once to the custody of the clerk of the Judiclary Committee?

The PRESIDENT: The Chair is of the opinion it requires concurrent action on the part of the House.

Thereupon, on motion by Mr. Carter of Androscoggin, the bill was sent down for concurrence.

Mr. MAHER of Kennebec: Mr. President, upon the matter which I gave notice on the last legislative day that I would move reconsideration, I now move reconsideration.

The PRESIDENT: The question is on the motion of the Senator from Kennebec, Senator Maher, that we reconsider the vote whereby we indefinitely postponed Resolve to appropriate money for the erection of a new State library (H. D. 21.) A viva voce vote being doubted

A division of the Senate was had. Three having voted in the affirmative and 22 in the negative the motion to reconsider failed of passage.

On motion by Mr. Case of Washington, the Senate voted to take from the table An Act defining dealers in motor vehicles (H. D. 326), tabled by that Senator on March 18th pending consideration.

Mr. CASE: Mr. President, I now move the adoption of House Amendment A.

Mr. FOSTER of Kennebec: Mr. President, may we have the amendment read?

The PRESIDENT: The Secretary will read the amendment.

(The Secretary read House Amendment A.)

The PRESIDENT: The question is on the adoption of the amendment.

Thereupon, House Amendment A was adopted and the bill as so amended was passed to be engrossed.

On motion by Mr. Oakes of Cumberland, the Senate voted to take from the table An Act in favor or Frank J. Durgin, (S. D. 239) tabled by that Senator on March 18th pending second reading, and on further motion by the same Senator the bill received its second reading and was passed to be engrossed.

On motion by Mr. Dwinal of Knox Adjourned until tomorrow morning at ten o'clock.
