Tuesday, January 8, 1929.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Porter of Gardiner.

Journal of the previous session read and approved.

The SPEAKER: The Chair will announce the appointment of the following members on the part of the House on the committee on Governor's message, provided for by the joint order passed January 3rd: Messrs. Kitchen of Presque Isle, Bishop of Boothbay Harbor, Gillespie of Meddybemps, Robie of Westbrook, McLean of Bar Harbor, Boston of Gardiner, and Thatcher of Bangor.

Orders

On motion by Mr. Rounds of Portland, it was

Ordered, that each member and officer of the House be supplied with a fountain pen.

On motion by Mr. MacKinnon of Mexico, it was

Ordered, that the Commissioner of Inland Fisheries and Game have the use of the Representatives' Hall Wednesday evening, January 9th, for a stereopticon lecture.

On motion by Mr. Blaisdell of Franklin, it was

Ordered, that the Superintendent of Public Printing deliver to the State Library as soon after printing as possible, twenty-five copies of the bills, legislative proceedings and all other publications printed by order of this House for ex-

change with other libraries and institutions.

On motion by Mr. McCart of Eastport, it was

Ordered, that each adjournment of the House be until 10 o'clock of the following morning unless otherwise ordered.

On motion by Mrs. Gay of Waldoboro, it was

Ordered, that the use of the hall of the House of Representatives be granted to the Federation of Women's Clubs on the morning of Friday, January 25th.

The SPEAKER: The Chair will call the attention of the members to the seating diagram which the members will find on their desks; also to the proofs of the Senate and House registers. It is requested that any inaccuracies which are found to occur on either of these papers be immediately communicated to the Clerk of the House. It is most important that these diagrams be strictly accurate.

From the Senate: Ordered, the House concurring, that the Superintendent of Public Printing be directed to handle all matters pertaining to advertising, printing, binding and committee binders for record of hearings as required by the Legislature.

In the House read and passed in concurrence.
