The SPEAKER: The Chair will take this opportunity to state to the members-to urge the members -to introduce into this Legislature as early as possible all bills and resolves which they intend to intro-The Legislature is now duce. ready to function but cannot function until there is something for it to act upon. If the bills and resolves can be introduced early in the session it means much in the way of expediting public business, and renders far easier a thorough consideration of the measures which are introduced, making the matters considered carefully in-stead of hastily. It is the duty of the members in so far as possible to impress this fact upon their constituents. If the practice of previous Legislatures should be adopted the time for introducing private bills and resolves would probably close some time the latter part of next month and public bills about the tenth of March. Early action is most important.
