#### HOUSE

Tuesday, January 22, 1929.
The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Clark of Gardiner.

Journal of the previous session read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: Ordered, the Senate concurring, that the Joint Standing Committee for this session on Inland Fisheries and Game be authorized to attend the New England Sportsmen's Show now being held in Mechanics Building in Boston, Mass., which was read and passed in the House January 15th,

Comes from the Senate indefinitely postponed in non-concurrence.

In the House, on motion by Mr. MacKinnon of Mexico that body voted to recede and concur.

The SPEAKER: This being an emergency measure, and requiring a two-thirds vote of the entire membership on its final passage, all those who are in favor of the final passage of the resolve will rise and stand in their places until counted and the monitors have returned the count.

A division of the House being had,

One hundred and twenty voted, all in the affirmative, and the resolve was finally passed.

#### Orders of the Day

Mr. ROUNDS of Portland: Mr. Speaker, I would like to reconsider the order relating to the time of reception of private bills.

The SPEAKER: Will the gentleman state what the order is to which he refers?

Mr. ROUNDS: It was passed last Thursday. The SPEAKER: It is not now in

the possession of the House.

Mr. ROUNDS: Will we have a chance to reconsider that today?

The SPEAKER: Does the gentleman wish to move that the order be recalled to the House?

Mr. ROUNDS: Yes Sir.

Rounds On motion by Mr. Portland, it was voted to recall to the House the order passed on Thursday last with reference to the reception of private and special bills.

The SPEAKER: The gentleman from Portland, Mr. Rounds, is advised that by the time the Assistant Clerk had reached the Senate, the order had received passage in the Senate, and there is nothing which the House can do with reference to that particular order at The gentleman today's session. may introduce another order if he desires, or may make a motion tomorrow with respect to the order passed in the Senate today.

Mr. ROUNDS: Mr. Speaker, all I wish to do is to protect ourselves. As I understand it could not go over another day.

The SPEAKER: The gentleman may make an appropriate motion at tomorrow's session.

Mr. ALLEN of Sanford: Speaker, I think, to have the right of way, that that order should be presented in writing. He can reserve his rights here this afternoon and preserve his rights tomorrow. I do not think he can have a verbal order recalled.

The SPEAKER: Is there further business under Orders of the Day? (No response)

On motion by Mr. Sargent of Brewer.

Adjourned until tomorrow morning at ten o'clock.
