Tuesday, January 29, 1929.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Milligan of Randolph.

On motion by Mr. Chase of Cape Elizabeth, it was voted to take from the table the second unassigned matter, H. P. 29, H. D. 9, resolve providing for erection of Equestrian Statue at Gettysburg in memory of Maj. Gen. Oliver Otis Howard, tabled by that gentleman January 23, pending reconsideration referred to the committee on Appropriations and Financial Affairs in the House, January 16, and returned by the Senate referred to the committee on Military Affairs in non-concurrence; and on further motion by the same gentleman the House vot-

ed to recede and concur with the Senate in the reference of this resolve to the committee on Military Affairs.

On motion by Mr. Rounds of Portland, it was voted to take from the table the 6th unassigned matter, being house report, ought not to pass, from the committee on Pensions on bill an act relating to pensions for the blind, tabled by the gentleman, January 24, pending acceptance; and on further motion by the same gentleman, it was voted that the report of the committee, ought not to pass, be accepted.
