On motion by Mr. Aldrich, the Joint Order was retabled and specially assigned for consideration tonorrow morning

The SPEAKER: The Chair presents the second unassigned matter bill an act relating to the collection of taxes, H. P. 166, presented by the gentleman from Boothbay Harbor, Mr. Bishop, and tabled by that gentleman, January 24, pending reference to a committee; and the Chair recognizes the gentleman from Boothbay Harbor, Mr. Bishop. On motion by Mr. Bishop, the bill was referred to the committee on Legal Affairs, and 500 copies ordered printed.

On motion by Mr. Rounds of Portland, it was voted to take from the table the third unassigned matter, an act to incorporate the New England Public Finance Company, S. P. 34, tabled by that gentleman yesterday, which was in the Senate referred to the committee on Banks and Banking; and on further motion by the same gentleman the bill was referred to the committee on Banks and Banking in concurrence.

On motion by Mr. Rounds of

Portland, it was voted to take from the table the fourth unassigned matter being House report, ought to pass, committee on Legal Affairs, on bill an act amendatory of Chapter 98 of the Private and Special Laws of 1927, entitled "An act to incorporate the Casco Title Guaranty Company," H. P. 8, H. D. 4, tabled by that gentleman, January 29, pending acceptance of the report; and on further motion by the same gentleman the report of the committee on Legal Affairs, ought to pass, was accepted. On further motion by the same gentleman, the rules were suspended, the bill had its two several readings and tomorrow assigned for its third read-

On motion by Mr. Mansfield of Jonesport, the House voted to reconsider its action of yesterday whereby it concurred in the Joint Order that 1000 copies of Commander Paul V. McNutt's address be printed for the use of the Legislature; and on further motion by the same gentleman, the Joint Order was tabled, pending passage in concurrence.

Mr. PERHAM of West Paris: Mr. Speaker, a short time ago there was an act, H. P. No. 34, introduced placing a bounty on bears in towns and plantations where damages were being caused to valuable domestic animals. This bill was referred to a Joint Committee on Agriculture and Inland Fisheries and Game. This morning we had before us, S D 47, which has been referred to the committee on Inland Fisheries and Game alone. These two bills refer to the same subject by reason of the fact of the last part of S. D. 47 providing "that nothing in this act shall be construed as prohibiting any person from killing a bear found doing damage to sheep or other domestic animals, or from having a bear in possession at any time, if lawfully taken in open season." Now this bill should be referred to the Joint Committee on Agriculture and Inland Fisheries and Game in justice to the members of the Eightv-Legislature who are infourth terested in agriculture as well as fish and game. Therefore, I move that S. D. 47 be referred to the Joint Committee on Agriculture and Inland Fisheries and Game.

The SPEAKER: The gentleman from West Paris, Mr. Perham, moves to take from the table, S. D. 47, bill an act to establish a closed time on bear, tabled by him earlier this morning.

The motion prevailed, and on further motion by the same gentleman the bill was referred to the Joint Committee on Agriculture and Inland Fisheries and Game in non-currence.

The SPEAKER: The Chair will

state in reference to further sessions of the House, that there will almost certainly be a session of the House on Friday, February 8, and on Fridays thereafter until the end of the session; that if there is not a session on Friday of this week, as seems doubtful, there will be a session at five o'clock tomorrow afternoon
