Mr. ROUNDS: Mr. Speaker, there seems to be a good deal of fun made over mosquitoes. The last few years I have sat here and heard them appropriate \$25,000 a year for developing the State of Maine. The State of Maine advertises for people to come in here. If they are going to do that, it seems to me that they should try to keep them here after they get them. It reminds me very much of a theatrical troupe that was barnstorming through the State playing that new play Uncle Tom's Cabin. They got stranded and could not get any further; so they hired a gentleman to bring the manager and ticket seller to the next town to sell tickets and the manager read the book so that the troupe could get out of the town where they were stranded and continue their tour. That looks to me very much like getting people into the State of Maine and not looking after them after they come here.

The gentleman who put this - 11 in is a New Yorker. He came to Portland and liked the State of What did he do? 'The first Maine. thing he did was to buy a large tract of land on the coast of Maine and ne got people from New York to come here. He spent over half a million Now he comes here and dollars. asks you if you cannot keep these people here. If you do not pass this bill, they will pull up stakes and leave the State. That man sent a lawyer from Portland to interview the State Board of Health. He could not get at the head of the Board. He got at a doctor connected with the State Board of Health, and the lawyer asked him what he could do, and he was told to go back and prepare a bill. He has prepared such a bill and if you want to keep such people in the State of Maine as this man, who has not only put \$500.-000 in taxable property into the State, but also has put one of the largest bakeries in this State, and last year increased it 25 per cent., not only that, but he has put his money into one of the largest dairy plants, not only in the city of Portland but in the city of Bath,—you should pass this bill. He likes the State of Maine. He did not have to come here for in the last year, he, with his family, put over \$800.-000 into a bakery in the city of Lynn. Do you want to drive such men as that from the State of Maine? I believe they are going to ask for \$50,000 this year to advertise Maine, and when they come here do you want to tell them that we do not want them?

A mosquito is a pest and in the interest of spreading disease should be suppressed. This the State of Maine at the present time is not doing I want to say that the State of New Jersey, the State of Florida, the State of Mississippi, and the State of Louisiana are all trying to stop the pests that they have at places in those states. Therefore, I think it is just to any men who come into this State and spend their money, and are willing to stay here, —I think it is time that we recognize them. Therefore I want to suggest that this should go to the committee on Public Health.
