Thursday, February 7, 1929.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Mc-

Whorter of Augusta.

Journal of the previous session read and approved.

On motion by Mr. Holman of Farmington the House voted to suspend the rules and receive an order, out of order.
