Mr. ROUNDS: Mr. Speaker, I now yield to the gentleman from South Portland, Mr. Boynton. Mr. BOYNTON of South Portland: Mr. Speaker, I would like the indulgence of the House to have that order tabled pending the preparation of an amendment.

Thereupon the House voted to retable the order, pending preparation of amendment; and on further motion by the same gentleman, Thursday, February 14, was specially assigned for its consideration.
